MINISTER'S REPORT. 1956.

Oct. 11, 1956

On every side there are clear signs of growth in our Church. It seems quite evident that the pains some of us feel are growing pains. In every society in Church there are new faces. New people with fresh ideas are joining our fellowship to strengthen it to fulfil its task in a growing community.

We are not only growing in numbers but in strength and deeper appreciation of what the Church means. Hence a Board of Deacons which is performing vital work and is planning to introduce a method to keep in closer touch with the members of our fellowship; a Finance Committee already adopting this method to deal with the Canvass; a Board of Trustees whose interest is evident in the improved condition of our Church property. In the Church School we have an excellent staff which means that no official is overburdened, apart from the fact that every teacher is burdened by woefully inadequate teaching facilities. For the first time during the present ministry we have an healthy Teacher Training Class. The missionary effort of the Church has reached a new high with the figure of \$1271. In our young people's work we lack lay leadership. We have a splendid Pilgrim Fellowship Choir without a leader. The Church Choir Director has willingly assumed extra duties to fill in this gap in lay interest, and merits, I suggest, some remuneration for her added travel, time and work. In spite of this lack of leadership our Young People are widening their vision of the Church and its mission: sending delegates to Youth Camps, to Conferences, and serving in the district and in the Church. This same broadening of visin is apparent in the Couple's Club, both in its work for the Church and in its providing opportunities for introducing new people to our fellowship. Church attendance during the year has not been good. Only the fact of well attended special services enables us to maintain the respectable average of 102. The fact that the new time of Church School takes certain worshippers from the service explains somewhat but does not excuse. We myst teach our people that the basis of Christianity is the worship of God.

Looking into the future we may predict something from the past. The excellent response to the Paint Fund suggests that we will deal adequately with the completion of the Mitchen. Also we are hoping for some alleviation of our classroom difficulties. I am anticipating some expression of the need for an Adult Bible Study group during the week. No Church is really strong without some such group.

This present Church year is our 225th Anniversary Year We can wake it a year to be remembered.

Report of Missionary Society

The Missionary Society of the First Congregational Church, Georgetown completed the fiscal year on June 5th 1956 in the church vestry,

with Miss Ida Bancroft and Miss Fannie Friend in charge.

The first meeting of the season was held on September13,1955 at the cottage of Mrs. Ruth Jones at Baldpate Pond, and continued with monthly meetings at the church and at the homes of the members during the year.

For our edification during the year we read the study book "They Reach for Life" and a truly enlightening and instructive book on

missions it has been.

Our work in the Mission Field has been varied. We have supported our church apportionment to Christiam World Missions with the sum of \$115.00. We have also supported, with money, The Walker Missionary Home, the Second Mile, which is in three portions 1-Massachusetts Negro Churches, 2-Mission in Angola, West Central Africa, 3-Ryder Memorial Hospital in Porto Rico. Members also contributed to the "One Great Hour of Sharing" on March 11th. We have supported, with gifts, the City Missionary Society, Congregational House, Boston, and we have contributed to the Delmo Housing Corporation of Lilbourn, Missouri, in memory of our beloved late member, Mrs. Minnie Longley. We have also provided our own church with flowers in memory of all our departed members.

We have assisted at the program of the World Day of Prayer, which was held this year in our own church, and which attracted an attendance

of eighty worshipers.
Socially we have extended our hospitality to the women of other churches in our greater community thru our Guest Day on November first, when we entertained at a tea in our church vestry, and sponsored a film "Lets Talk Turkey", which delineated the beauty of that country, the custom of its people, and their efforts to build a new democracy. Guests were present at that time from churches in Boxford and Byfield, as well as the local Baptist, Latter Day Saints, and Episcopal Churches.

During the year we have been saddened by the death of one member. We have made some gain in membership, however, our membership at presen numbers sixteen, and we are heppily anticipating several new members

in the next season.

CAMPFIRE GIRLS REPORT

Camp Fire Girls and Bluebirds, comprising our Church and Church School children and several of their "buddies" from other Churches, from the ages of 7 to 14, have met in this Church for 3 years, this being the beginning of our fourth full year. Our record of service is as follows:

In 3 Christmas seasons we have made about 200 dolls and stuffed animals, to be distributed through the Church School Home Missions program, to needy areas. This has been counted on the missionary quota for the Church School.

The Camp Fire table at the Church Fair contributed \$15 one year, from stuffed toys, candle stands, etc., and the following year their white elephant table was also successful, clearing \$12 for the Fair. The girls have also sold tickets for other organizations for suppers or entertainments, when asked.

Outside the Church we have contributed Easter baskets to a children's hospital ward, the baskets being presented by the children in person. Seven dish gardens have been made and taken to different homes and institutions. They have made tray favors and small corsages of wild flowers for the Old Ladies Home in Haverhill, also entertained these ladies with carols at Christmas.

Their work for home missions this year will be a mitten tree, each member of the organization will make a pair of mittens to be hung on a Christmas tree, then distributed to needy persons. We at all times try to keep before us the third Law of Camp Fire, which is "Give Service."
