### REPORT OF THE MINISTER

It is difficult to put down precisely what has been accomplished in the past year. We can point to the renovation of the organ, although it is costing us almost twice as much as was first estimated. We can console ourselves about the cost by saying that the repairs were long overdue, and that they should prove to be a wise investment over the years to come. We can point to the three lots of land we are buying on Cottage Street and visualize their value to us in the years to come. These are good things that we have done; but these things do not tell us how well we have carried out the mission of the Church.

Taking into consideration the major expenses involved in paying for the organ and parcels of land, financially we are doing better than in past years. We have been able to pay our regular expenses on time. But lest we get content in our stewardship, bear in mind that neither the total bill for the organ nor the bills for the last two lots of land are paid as yet. Furthermore, had all of the committees spent all the money that the budget allowed them to spend, we would have been in financial trouble. For the first time in recent years we were able to pay to Our Christian World Mission the full amount we aimed to. I interpret this to mean that we are becoming more aware of our mission as Christians to the entire world.

The spirit of cooperation shown in the Church Fair and in the work parties who tore down the old house on Cottage Street built up interest and enthusiasm. The ecumenical spirit has grown during the past year as seen in the Thanksgiving Eve Service in St. Mary's Church, the ecumenical Chinese Dinner in our own church, the combined Christmas dances held by the Couples' Clubs and Men's Club at St. Mary's and the Pilgrim Fellowship and C. Y. O. at our church.

I enjoy working with the Pilgrim Fellowship and am pleased that five of them attended Star Island Conference this past summer. Some of our teenagers have become enthusiastic about the Pilgrim Fellowship Weekend Conferences, held at our Conference Center in Framingham. I hope that during the coming year more adults will take advantage of chances to meet in depth with others. As the spirit of cooperation deepens it may be the time to have discussion groups with our Catholic friends. Through such experiences we can, hopefully, move toward constant commitment to our Church and its ongoing ministry.

One group that needs help now is our Choir. There simply aren't enough in it. Don't just sit back and agree with me that we need new members. Do something about this need yourself. Otherwise I may be forced to start running back and forth between the pulpit and the choir loft!

As your minister I simply assume that you expect and should have commitment and loyalty from me. Is it too much for me to expect faithfulness to God and this Church from you? At times I get the

feeling that some members spoil the image of our Church by their casualness toward it. This hurts everybody. Other organizations and clubs demand and expect greater loyalty and respect than the Church receives from some of us. For your own good and the benefit of your family as well as for the sake of your fellow men, tend to your spiritual health and growth through the Church.

During the years the demands for counselling have increased, from people in town as well as from members of the Church. This is a most important part of my work and receives priority in time alloted to it. Those who have been ministered to can assess the good that has been done better than I. But I do know that in many instances there has been growth and development, that some have found greater peace of mind; while, admittedly, in other situations we have just been scratching the surface and making little headway.

Let me make a suggestion to those who would like me to call on them. Let me know by calling me or through the deacons or deaconesses. Help me further serve you by telling me what you want to see me about. It is ever so much easier to talk intelligently when one already has at least an idea of what is on the other person's mind.

## REPORT OF THE CHAIRMAN OF BOARD OF DEACONS

# REPORT OF CHURCH SCHOOL SUPERINTENDENT

Our Church is very fortunate to have an enthusiastic, capable group of Church School teachers who give much thought and care to the teaching of our children. A good teacher does more than just prepare a lesson for Sunday morning. To help children become aware of God's love is a challenging task, but most teachers will agree that they get back much more than they give.

In addition to their weekly classes the Church School have had some special events. Last spring the school enjoyed playing a part in the Guild's Stunt Night. Our Children's Day in June was an attempt to present a real worship service. We used hymns, prayers and scripture reading which the children had learnedin the course of the year.

The painting of Metcalf House was finished last spring, with a large assist from Mr. Charles Kent. We are sharing the house with some public school classes this year. The school officials have been very anxious to cooperate with us in every way.

This fall several of the teachers attended a workshop at the Byfield Parish Church. We are planning a general teachers meeting this January to discuss our progress for the year.

We have extended our Church School for grades three through Senior High by fifteen minutes. We begin the morning by meeting to sing together for fifteen minutes, with Rev. and Mrs. Southwick leading the singing.

The entire Church School presented a Christmas program in December. We tried to make this an all school project. The nursery and kindergarten made decorations for the Christmas tree. The teachers decorated tables. Many of the children drew pictures and we used some of these for the Newsletter and for the program cover. Some of the Senior High made scenery and many took part in the program.

Working with children in these various ways is really fun - as they are very responsive. Most of us wish that we could do a lot more, but I do believe that our children are benefitting by the love and interest shown by all the workers in our Church School.

# Pilgrim Fellowship

# REPORT OF THE PILGRIM FELLOWSHIP

This year in Pilgrim Fellowship has been a year of renovation in recreation, service, and philosophy. We have had varied recreational activities. A few examples of these are; hockey games, a Celtic's basketball game, a trip to see the movie, "The Bible", bowling, roller skating, a joint weekend retreat with the Lynnfield Pilgrim Fellowship, a dinner meeting with the Rowley Pilgrim Fellowship, a joint Christmas dance with the Catholic Youth Organization of Georgetown, and several motion pictures shown at our Church.

In the area of service we have taken on a special project of giving support to the Crotched Mountain Rehabilitation Center in Greenfield, New Hampshire. We took car loads of toys, food, and clothing to the Center this fall and spent the afternoon playing with the crippled children and blowing up the 250 balloons we brought for them. More trips to Crotched Mountain are being planned. We continue to keep the Carleton Home shoveled out after snow storms. On Christmas Eve, the Catholic Youth Organization and the Pilgrim Fellowship went carolling at the Carleton Home and also at Baldpate Hospital. Each week, boys from the Pilgrim Fellowship serve as ushers in Church.

As the group becomes an older one, the philosophy of the group has had to change. We have moved from a policy of having the advisors plan and direct the meetings to one of having the Pilgrim Fellowship Officers plan and run the meetings with advice and supervision from the advisors. We are experimenting with our worship services to make them more meaningful with the use of music, poetry, book readings, and slides. We hope to achieve a more meaningful and active Pilgrim Fellowship, by instilling in ourselves the elements of fellowship, brotherhood, and responsibility.

### **Trustees**

#### REPORT OF THE BOARD OF TRUSTEES

The Trustees have been very active this year. Regular monthly meetings were held for nine months, and work parties were held in June, July, and August. The Church cellar, Metcalf House cellar and garage were cleaned.

Repair work on the Church Organ was started April 24th. As work progressed, additional problems were discovered, and the Andover Organ Co. informed us that the cost of the job would have to be revised from \$4,000.00 to \$6,000.00. Mr. Donald Taylor met with the Cabinet and other interested people, and explained the problems that had not been expected, and could not be seen until the organ was dismantled. After much consideration, it was agreed to proceed at the revised figure. Work progressed very slowly and was not finished until September. About this time we received word from the Andover Organ Co. that the bills totaled around \$7,800.00. We are still trying to negotiate for a revised figure.

Mr. and Mrs. Donald Elliott were most considerate and generous in loaning their fine organ to the Church during this period.

The School Department requested the use of four rooms in Metcalf House for special classes. This request was granted until the new school is ready. The School Dept. is paying for all utilities while using this building.

We were authorized to purchase the property at 5 Cottage St., dispose of the building, and improve the lot for a parking area. The purchase was made after much assistance from Mr. Robert Metcalf.

The Couples Club was asked to take over the Cottage St. project, and in December, tore the house down, took it to the dump, graded and filled the lot with 6 loads of gravel and removed 5 trees. Many thanks to the Couples Club who paid all the bills, and to everyone who helped, especially to Walter Snow with his truck and bulldozer. This was a job well done, and a great improvement to the Church property.

The Georgetown Historical Society was granted use of the Vestry for one night a month.

The Girl Scouts were granted use of the Vestry for one afternoon a week.

The following work was done on the Metcalf House:

- 1. New rubber tile over plywood floor installed in upstairs
- 2. Shut-off valves installed on all bathroom fixtures.

3. Rear gutter repaired.

4. Storm and inside windows repaired.

5. Chimney repaired.

- 6. Septic system repaired and new drain field installed. (by the School Dept.)
- 7. Crash bars installed on exit doors. (also by School Dept.)

The fence around the property at 3 Cottage St. was rebuilt. The hand rails at the front walk of the Parsonage and Clark St. entrance were sanded and painted with primer and finish coat.

The flood lights and several windows at Church were repaired. The Church septic system was pumped and cleaned in November. Charlie Woodburn is still doing a very good job as landlord for the 3 Cottage St. property.

Mike Maloof continues his work with us as sexton. We thank the Elliott Brothers for service and advice on occasional heating problems and for the use of a dump truck when needed.

#### Dear Mina:

This morning as voted by the cabinet last evening I talked at some length with Mr. Taylor of Andover Organ with the following results:

- 1. Andover Organ has now placed us on their schedule for the organ repair.

## REPORT OF THE FINANCE COMMITTEE

A budget of \$31,636.00 was accepted by the Church membership for the year 1967.

Working with this budget, the Finance Committee met each month to pay current bills and to discuss means of meeting our extended financial obligations.

We had a good year financially, paying all current bills. However, we did exceed the proposed budget as a result of the following unexpected expenses:

1. Purchase of the Rogers property on Cottage St. \$4,000.00

2. Additional expense to repair organ. \$1118.46
Present cost of the organ repair is \$7,891.46. All but approximately \$2,000.00 of this has been raised.

The Every Family Canvass for 1968 was held in November, as usual, with many members participating. However, the results were not as favorable as expected. There were 160 pledges made with 16 additional families requesting envelopes only.
