January 26, 1989

The Annual meeting of the First Congregational Church of Georgetown was called to order at 8:05 PM by Donn Chatterton, moderator. Rev. Southwick opened the meeting with prayer. There were 42 members present.

Donn welcomed everyone to the annual meeting. Copies of the clerk's report of the January 28, 1988 meeting were given to members as they arrived. Additional time was allowed to read the report. It was accepted as printed.

The following listed articles were acted on:

ARTICLE 1. To receive the reports of the several boards, committees and officers of the church, and to take action thereon;

Time was given to all members to review the reports booklet. Report of the Nominating Committee will be presented under Article 4 and the report of the Renovation Committee will be presented under Article 5.

Bud Hamelin moved that the reports be accepted as printed, seconded by Betty Jo Fawley, so voted.

ARTICLE 2. To hear the report of the Finance Committee regarding a church budget for 1989, and to take action thereon;

Allan Barlow explained the 1988 Financial Reports depicted in a chart comparing the 1988 proposed budget, the actual 1988 budget and the proposed 1989 budget. The grand total receipts for 1988 was \$104,948.00 and the grand total disbursements was \$93,859.00. Allan noted that the proposed budget deficit for 1988 current expenses was \$10,007.00 and the actual deficit was only \$1712.00. People pledging money gave more money than they pledged.

Allan Barlow moved that the church accept the proposed budget for 1989 as printed in the FINANCIAL REPORTS section of the 1988 Annual Reports of the First CongregationlChurch of Georgetown, seconded by Dwight Southwick, so voted.

ARTICLE 3. To see if the church will authorized the Finance committee to borrow from any of the Capital Investment Funds, if needed, in anticipation of income to pay current expenses and further, to transfer funds from any of the Capital Investment Fund accounts to the Current Expense account in the event that income for current expenses does not meet the budget expectations;

Allan moved that the church vote to authorize the Finance Committee to borrow or transfer money from any of the Capital Outlay Funds, except Memorial and Building, to the Current Expense Budget, in the event that receipts for Current Expenses are less than budgeted or are timed such that cash flow problems occur, seconded by Forrest Bridges, so voted. ARTICLE 4. To hear the report of the Nominating Committee and to take any action required thereon;

Virginia Ryder presented the slate of members to be elected to committees as disignated.

Betty Jo Fawley moved that the Nominating Committees' nominations be accepted, seconded by Don Ames, so voted.

ARTICLE 5. To hear the report of the Renovation Committee;

Frank Stewart, representing the Renovation Committee, gave a chronological report of the committee's activities from December of 1985. He touched upon <u>A New Vision</u> which is the committee's recommended approach presented at the 1987 annual meeting. At this 1987 meeting the Renovation committee was authorized to obtain quotes for the design of an addition to the main church building. The search for quotes could not exceed the expenditure of \$3000.00

At the January 28, 1988 annual meeting Jim Collin reported that representatives of the committee had met with and narrowed down their choice of architects to two firms. No cost was incurred in this initial search of an architect. The next step would be to choose an architect to draw up plans for an addition or stop at this point. After much discussion it was voted to authorize the Renovation Committee to hire an architect and expend up to \$10,000.00 for the purpose of designing an addition on the rear of the church edifice. Satillite Building Corp. became the chosen architectual firm.

Challenges to be met by the committee with the architect were:

- 1) maintain the present character of the exterior of the church when designing the addition
- 2) improve access to the church
- 3) identify and stay within state and local building codes
- 4) identify a parking scheme
- 5) design an addition which we can realistically obtain
- 6) improve kitchen facility
- 7) provide larger office space for minister and secretary
- 8) provide "meeting rooms" within the church
- 9)) provide area for an elevator
- 10) increase storage area
- 11) update tolet facilities
- 12) provide space for the Thrift Shop

Frank presented a slide show and architectual drawings noting that this is a starting point only. No decision has been made to build the addition. This is a proposed project. Notes made during slide presentation:

#### EXTERIOR

- 1) Brick foundation will extend around addition and blend into presently existing brick.
- Must maintain access around exterior of building to meet fire code.
- 3) Parking area will be provided on side of church.
- 4) The new structure will be treated as a separate unit from the existing structure. The new structure must have a sprinkler system. A fire wall will be installed between the existing building and the addition with fire rated doors entering the new addition.
- 5) The back peak will follow similar lines to the existing peak, thus blending nicely with existing structure.

#### FLOOR ONE

- 1) existing conference room
- 2) new entry way
- 3) shaft for elevator
- 4) two handicapped toilet areas
- 5) sexton room
- 6) two large meeting rooms
- small meeting room beside the kitchen or possible area for extension of kitchen
- 8) one large meeting area to function as Thrift Shop

#### FLOOR TWO

- 1) two bathrooms
- 2) three meeting rooms
- 3) minister's office
- 4) secretary's office
- 5) one meeting/music room
- 6) storage room

#### FLOOR THREE

- 1) storage area
- 2) one large meeting room
- 3) present windows in choir loft can become doors or remain as windows

If the elevator extended to the third floor it would become very costly because of codes.

The addition would be built on a cement slab. The same kind of siding presently on our church is available and would be used for the addition. The main entrance to the church would open to Cottage Street where a parking area would be developed. The church property has been surveyed.

Frank noted that he would like to see a "reflection period". In this time meetings would be scheduled to review the plans with all interested church people. At the end of this period all inputs will be considered by the committee and final drawings will be made.

#### DISCUSSION:

- If the windows in the choir loft are removed what provisions for ventilation will be made? It was noted that they are presently closed and are not used for ventilation at this time.
- 2) Where is the separate mechanical room? This is located by the elevator shaft. (sexton room)
- 3) Can the existing furnaces supply the new building with heat? This is a possibility.
- 4) What is the estimated cost of an elevator? Answer: \$30,000 - \$40,000.
- 5) Will it be extended to the third floor? No as the code requirements over two floor is extensive thus increasing the cost.
- 6) Does the estimated cost include finished walls, carpeting, tiles, lighting, tolet fixtures? Answer - yea.
- 7) What would the additional cost be to use a steel frame? Unknown.
- 8) We should consider additional use of our building such as daycare for children or elders. Will we meet other needs?
- 9) Did the committee consider a chair lift? The committee was opposed as they felt people will not use a chair lift in view of other people. There is no stigma to use an elevator.
- 10) What replaces space where present toilets are located? This becomes a hallway and provides access to underside of church.
- 11) If the kitchen outer door is eliminated will this propose a problem when people bring food to the church? The new door is located only a few more feet from the present door. It might help to eliminate some kitchen traffic.
- 12) How many main entrances will there be? Will more greeters need to be posted?
- 13) How do the people get copies of the drawings of the proposed addition? They will be made available for members before the proposed meetings.
- 14) It is estimated to paint a church of our size it now costs \$175,000.00.
- 15) What was the cost to build the Byfield Parish Church? Unknown.

Allan Barlow moved that we accept the report of the Renovation Committee, seconded by Betty Jo Fawley, so voted. ARTICLE 6. To take any other action relative to the church and its property.

- a) Betty Jo Fawley thanked Joan Chatterton for 1988 Reports cover acknowledging the Women's Guild for 65 years of service.
- b) It was noted that on January 29th there would be a pulpit exchange. Rev. Southwick will travel to the Wenham Congregational Church and the Rev. Warren Johnson will be our guest preacher.

With no further business to discuss Bob Knapp moved that the meeting adjourn, seconded by Jackie Moore, so voted.

The meeting adjourned at 9:59 PM.

#### WARRANT

The members of the First Congregational Church of Georgetown are hereby advised that, in accordance with the constitution and by-laws of said church, a special meeting of the church will be held Thursday, June 15, 1989 at 7 p.m. in the church vestry, then and there to act on the following listed articles:

ARTICLE 1. To hear and act on the report of the Renovation Committee.

- ARTICLE 2. To see if the church will vote to accept the plans for the addition to the church edifice as developed and presented by the Renovation Committee in January 1989, and amended in May 1989.
- ARTICLE 3. To see if the Church will vote to authorize the Renovation Committee, with the approval of the Cabinet, to obtain a suitable bid or bids for site preparation and construction of the proposed addition to the church edifice, and further, to authorize the Renovation Committee, with the approval of the Cabinet, to select and accept a suitable bid or bids, totalling less than \$400,000, and enter into contract with the selected bidder or bidders for site preparation and construction of the addition, and further, to authorize the Finance Committee, with the approval of the Cabinet, to borrow up to \$300,000 to finance the site preparation and construction.
- ARTICLE 4. To see if the church will vote to authorize the Renovation Comittee, with the approval of the Cabinet, to obtain bids for the sale of Metcalf House, or Metcalf House and a suitable lot surround it, if necessary, to obtain sufficient funding for site preparation and construction of the church edifice addition, and to present such bids to the church for appropriate action.
- ARTICLE 5. To see if the church will take any other action relative to the church and its property.

June 15, 1989

A special meeting was called to vote on the renovation of our church by means of an addition to the existing building.

Moderator, Donn Chatterton, called the meeting to order at  $\Im$ :10 PM with prayer lead by the Rev. Southwick.

There were five articles to act on.

Article 1 To hear and act on the report of the Renovation Committee.

Frank Stewart noted that the proposed addition is the culmination of three years of work in which the renovation committee identified our most urgent church needs. Combining our needs along with reasonable costs was not an easy balancing act. There were many ideas put together, surveyed, taken apart and restacked before the final proposal came together.

One of the most urgent established needs was a safe, updated environment in which to conduct classes for children. Frank and Bob worked with Dorothy Blanchard and together they determined more space was needed for the class rooms and therefore an additional four feet extension has been proposed to the back of the proposed addition resulting in:

- 1) two enlarged meeting rooms located on the first floor back wall
- 2) enlarged handicapped bathrooms
- 3) increase in back corridor width to  $4\frac{1}{2}$  feet
- 4) three enlarged meeting rooms and minister's study located on the back wall of the second floor
- 5) enlarged conference room/chapel area on the third floor

The proposed music room would be a multiple purpose room with its primary use by the Sunday School if necessary.

Although Frank expressed that he hoped we had the courage to say yes, he noted that the articles would be voted on by individual paper votes, that we disagree with respect for one another's ideas, remain friends and go forward no matter what the outome of the votes is.

Previous to this meeting there were three scheduled meetings opened to all members and any other interested people to view diagrams and hear the proposal of the renovation committee.

Joan Chatterton moved that the church vote to accept the report of the Renovation Committee, seconded by Craig Southwick, so voted.

Article 2 To see if the church will vote to accept the plans for the addition to the church edifice as developed and presented by the Renovation Committee in January 1989, and amended in May 1989.

Bob Knapp moved that the church vote to accept the plans for the addition to the church ediface as developed and presented by the Renovation Committee in January 1989 and amended in May 1989, seconded by Allan Barlow.

Discussion:

Are the mechanical plans ready? The architect has promised them but they are not available yet. Anticipate they will be ready in the near future. What kind of heat will be used? Can the present system supply the addition? Unknown to be determined. Will a sprinkler system be installed? We will meet town fire laws. The Sunday School Superintendent noted that the new space would provide a safer environment and also give some additional space but questioned if it were enough. Much room is needed on the first floor for children through kindergarten. Dorothy would like to see Metcalf House kept for a Thrift Shop and use the allocated space for the Thrift Shop for class area. She would also like to see a music Dorothy also noted that at present some classes are combined toom. into one group and hopefully they will have to split with additional growth. Frank noted that there is about a 65% increase in space for church school and feels this will provide ample space. Someone requested the specific measurements of each room in the proposed addition. These are not currently available. A letter from a nearby resident was read noting that there is not

enough parking spaces and causes congestion on Middle Street and she is not in favor of an addition unless "the church service approaches 100% capacity".

With no further comments or discussion a vote was taken by individual paper ballot. Results:

Yes	56
No	13

Therefore the article was passed.

Article 3 Bob Knapp moved that the church vote to authorize the Renovation Committee to obtain suitable bids for site preparation and construction of the proposed addition to the church ediface, and further, when the Finance Committee and Cabinet are satisfied that suitable funding is available, to authorize the Renovation Committee, with the approval of the Cabinet, to select and accept a suitable bid or bids, totalling less than \$400,000 and enter into contract with the selected bidder or bidders for site preparation and construction of the addition, and further to authorize the Treasurer, with the help and approval of the Finance Committee, to borrow up to \$300,000 to finance payment of said contract. Seconded by Allan Barlow.

Allan Barlow distributed a chart noting available funds and amount of money to be raised. \$12,000 was the amount of money members indicated they might give to the church along with \$63,000 in capital funds on hand for an initial down payment. Going along with conservative estimates of funds the sale of Metcalf House and land would add \$100,000 towards the fund. The maximum amount of money we can afford to borrow is \$175,000. The 175,000 figure is a conservative number concluded from awailable funds and the survey responses. Discussion:

Frank noted that the goal of the committee was to stay under \$300,000 but with the additional footage to the back of the building there would be an increase of \$40,000 to \$50,000. The Renovation Committee sent out 160 questionaires and 70 completed forms were returned. The questionaire indicated the desires of the church people.

Someone questioned if a loan is contingent on the sale of Metcalf House. Also how is this project going to be funded? A Fund Raising Committee will be formed to address money situation.

The problem of falling slate from the steeple was noted. Do we have a plan to correct this? The Trustees will look into this again.

What happens if the funds are voted down? Reestablish goals.

Will all money be tied up in this project for the next thirty years? Many times projects are paid for earlier than anticipated as in the church siding program.

Can we sell Metcalf without land? Will the value of Metcalf decrease with a three story building located next to it?

Can the addition be phased in? Although it was originally planned to be done in phases the survey indicated to go with total project.

What is the percentage of overrun? Is the \$350,000 estimated cost current? The committee feels it is a good estimate for today. Is the septic system part of site preparation? Yes.

With no further discussion an individual paper ballot was taken.

Special Congregational Meeting - June 15, 1989

Tally on Article 3YES47NO19UNDECIDED1

ARTICLE 4, presented by Bob Knapp, has been changed slightly from the original warrant. It reads:"I move that the Church authorize the Renovation Committee, with the approval of the Cabinet, to sell Metcalf House, or Metcalf House and a suitable lot around it, if necessary, to obtain sufficient funding for site preparation and construction of the approved addition to the church edifice."

Motion seconded by Lillian Grissino.

Explanation of the revised article: This gives the Cabinet the authority to act on behalf of the Church.

Discussion: Objections from the floor included concerns about selling the property too hastily before all avenues of pledging and fund raising are explored; the feeling that the "land should be how this saved"; about configuration of the lot required by codes - could affect encroachment on our church property; and do we have enough parking?

Frank Stewart and Bob Knapp addressed these concerns: Metcalf House property was properly purchased many years ago and has served us well. However, it should be used at the present time for debt retirement - that it is a wise use of this resource to enable us to move ahead. There will be an orderly transition of Church School classes, so construction and sale of the property will fall in logical order. Parking facilities: The spaces that are created on Cottage Street can be developed into flexible parking. Committee for the purpose of raising funds to pay for the site preparation and construction of the addition to the church edifice." Seconded by Cathie Southwick. So voted.

Dwight Southwick moved that the meeting be adjourned. Seconded by

Rob Knapp.

## MINISTER'S MESSAGE

The years do quickly speed by. This has been a year of great cooperation by all the Church Officers and committee people. Thank you all for being so willing to serve, and cheerful about doing whatever had to be done. It has been a year of growth and decisionmaking. We have been intentional about both.

The experiment with 10:30 worship, which began in September 1988, has solidified into an accepted time. The participation, and lingering at coffee hours, indicate that we enjoy the fellowship, and are still getting home before the noon hour is over.

Our Church School Superintendent reports that wonderful problem of overcrowding in the very young age brackets of our Church School. We have several new families in the church with young children decidedly a good omen for the 1990's. On Pentecost, last spring, we had a fine group of new members, several of whom are already active in the life of the Church - again, an intentional part of church growth.

Hooray! During 1989, we prepared a new church pictorial directory, thanks to the coordinating abilities of Bonnie Skinner. The entire operation ran very smoothly; most people were pleased with their pictures, and everybody is delighted with the finished product. It has been updated with an addendum of changes between the time we sent the proofs off, and when the directories came back for distribution. There will be a yearly update every fall until it is time for the next directory. It is another tool for bringing us closer as a Church Family.

The "name tag project" languished for a spell, while we tried to figure out the best way to store them. Those downstairs (Narthex) blinds proved to be more useful than ornamental. Thank you for being willing to wear your name tag when asked to. Some churches try to use them every week. We intend to use them from time to time, particularly on special occasions. This is another innovation we've tried based on suggestions from church growth meetings with other churches.

The Diaconate is working on a shepherding program which will enable us to keep in better touch with all our Church Family.

1989 marks the end of 24 years of paper drives. We sponsored twospring/fall - and carried them out (without remuneration in '89) as community service projects. The drives have always been helpful to the elderly, and they have prevented literally hundreds of tons of paper from being dumped. Times have changed. The markets for used paper have dwindled, while some towns and cities have stepped up their recycling efforts. We no longer have a source for mixed paper collections. Recycling is a sound idea. We sincerely hope for a solution to the problem. This has been a Youth Group project, ably assisted by many devoted, sturdy adults. Our appreciation to all who have participated over the years.

#### Minister's Message

Pam Feitz has made it known that this will be her last season as Youth Group Advisor. She led the Junior Highs for several years, and during 1989, the combined Junior/Senior High P.F. We appreciate her dedication. Pam brought home to our youth the issue of the homeless by having the group prepare meals for Emmaus House, take food offerings, and spend time with the children at the shelter. May our youth see this as their form of ministry. To Pam, we say, "well done - a schoolage generation of teenage youth has prospered under your energetic and caring leadership".

In June we made one of the biggest decisions in the history of this Church. At a special meeting we voted to move forward with an addition to our main structure, and to raise the funds to pay for it. The plans were presented on three different occasions: the evening of the Annual Meeting, a Sunday afternoon, and a Sunday forenoon, as we tried to provide opportunities for all the Church Family to see, hear, and discuss the plans before voting on them. Bob Knapp and Frank Stewart, from the Renovation Committee, did a super job of presenting the plans and answering the many questions raised.

All, who attended the Special Meeting, felt the sense of oneness among us - a people struggling to make a decision about a part of our lives, our Church Home. The spirit of fellowship was wonderful and has continued, even where there are differences of opinion.

During the summer, our Moderator, the Chair of the Finance Committee, and I came up with a list of prospective Capital Fund Raising Committee members. That committee has been charged with finding ways for us to finance the addition we voted for, ways for us to build for the future of our Church as others before us have done. We celebrate your willingness to serve, your enthusiasm for a challenging project. We eagerly await news from you in the coming months.

I thank you for your love and cooperation in the years past, and look forward to ministering with you during the 1990's.

#### REPORT OF THE CHURCH CLERK

The Annual Meeting, held on January 26, 1989, was attended by fortytwo members. Along with our regular agenda of receiving reports of the several boards, committees and officers of the church, was a report from the Renovation Committee. Again, an outline of the path traveled by committee members to date, was presented. After addressing questions by members, it was noted that mini-meetings would be scheduled in the spring. Individual copies of the floor plans were made available for anyone who wanted one.

The Georgetown Rainbow Girls took an active part in our Sunday service on April 9th. They were well represented, and we enjoyed their participation in our service as all of us recognized Rainbow Girls' Sunday.

The Rowley Congregational Church celebrated its 350th anniversary. In recognition of this event, a gift from six "daughter churches" was presented to the Rowley Church at a special service celebrating their anniversary.

Action taken by the Church Cabinet:

- In February, it was voted to contribute 20% of the Lenten Offering to Habitat for Humanity. The money is allocated for building homes for low income families/Greater Lawrence.
- 2) It was voted to produce an updated pictorial directory. Bonnie Skinner oversees this project.
- 3) It was voted to have Dwight Southwick and Betty Jo Fawley fill vacancies on the Renovation Committee, resulting from the relocation of two members.
- 4) It was voted in May to schedule a Special Meeting on June 15th to vote on whether to move forward on plans for a church addition, or vote against the proposed project. It was also voted to use a secret ballot system as requested by some members.
- 5) At a special Cabinet meeting, June 5th, the Cabinet authorized the Renovation Committee to mail a cover letter and warrant of the June 15th meeting to church people before June 15th.
- 6) A Fund Raising Committee has been established to look into methods of raising money for the addition to our church. Members were nominated by the Moderator, Finance Committee Chairman, and Minister. They were approved by the Cabinet.
- 7) At a special Cabinet meeting on September 24, it was voted to have the exterior of Metcalf House painted as there were specific funds available to keep that exterior in good repair; these funds would cover most of the cost.
- 8) In October the Cabinet recommended to the Finance Committee that money collected for the Advent Offering be used toward renovating our heating system. It was voted to give 20% of the Advent Offering to the Hugo Hurricane Relief Fund.

## Clerk's Report:

- 9) In November the 20% offering to Hugo Relief Fund was amended to include disaster relief for the victims of the San Francisco earthquake.
- 10) It was voted that 1/3 of the Christmas Eve offering be put toward the new addition with 2/3 going toward current expenses.

At a Special Meeting, June 15th, the Church voted to accept the plans for the addition to the Church, authorizing the Renovation Committee, with approval of the Cabinet, to obtain suitable bids. It was also voted that Metcalf House would not be sold without a membership vote.

Barry Games was in charge of changing the pulpit cover sets according to the religious calendar. As Chairperson I knew that when Barry accepted this responsibility, I would never have to think about the changing of cloths again.

#### HIGHLIGHTS OF 1989

Our Church participated in a Pulpit Exchange with the Wenham Congregational Church. The Rev. Warren Johnson was guest preacher, and the Rev. Southwick was guest preacher of the Wenham Church.

A Lenten series was offered on three consecutive March Wednesday evenings, led by Phil Southwick, on the actions of Judas, Pilate and Peter.

A joint Maundy Thursday service was held on March 23rd at the Groveland Congregational Church. Four members, representing our Diaconate, participated in the service.

John Westerhoff spoke at the Topsfield Congregational Church, April 29-30, on "The Future of Sunday Morning". He talked about more give and take between the minister and congregation during the church service. He suggests that the adults and children become more active participants in the service. By having some of our Diaconate members attend these meetings we become aware of "happenings" in other churches; we are introduced to new ideas which might be appropriate for our Church.

Jan Spence, with help from Joe Rawlins and Joan Chatterton, set up a name tag board in the Narthex on the window shutters. It is very creative and most attractive. On special occasions, one approaches the greeters and finds three or four Diaconate members ready to pin you. In this manner we are able to recognize one another by name.

#### Diaconate Report Continued:

Estelle Passeri of the Diaconate is coordinating meals for Emmaus House. Once every two months a complete meal is prepared and served to residents of Emmaus by people of our Church. About thirty-five people are served at each meal.

On May 21st, fourteen adults joined the membership of our Church. We are happy to have new members amongst us in our spiritual growth.

Joint summer services were held with West Boxford from June 18th through September 10th.

In October, a Fall Resource Festival was held at the Second Congregational Church of Beverly. "Getting People in the Doors" was the topic of the Rev. Fred Atwood-Lyon. Once again I recognize that many of the suggestions for church growth are already in place at our church.

Periodically the Sunday Service is taped. Presently two services have been taped and are available for your listening by calling the Church Office.

A committee has been formed to organize a program of special recognition of members who have served our Church over a long period of time. A temporary date of April 22nd, 1990 has been designated.

On November 14th, Erv Bode, Northeast Area Minister, spoke to the Diaconate on the subject of "Shepherding". This is a program whereby the Diaconate members will contact all members of our Church, encouraging them to participate in Church activities, and identify their spiritual needs.

On December 24th the Candlelight Service once again filled our Church with people and light. This is the Christmas event which I look forward to with a warm inner feeling as families gather together to celebrate His birth.

Interwoven with our monthly highlights are visits to those people unable to attend Church regularly. Often times a ten minute visit turned into one hour with the Diaconate member gaining much satisfaction, and leaving the visitation scene wondering if he/she gave as much as he/she received!

I wish to thank the Diaconate members and everyone else who helped us to carry out our duties.

To the Rev. Southwick we thank you for your guidance in helping you to "carry out the spiritual work of our Church".

# REPORT OF THE BOARD OF CHRISTIAN EDUCATION

The Board of Christian Education oversees all curriculum and programs of the Church School, Youth Group, and any special adult education. We are happy to report on a busy, productive year in the life of our Church, especially the Church School and Youth Group activities.

The Nursery, two and three-year-old group has grown this fall, so we needed to ask more mothers to help us out on a rotating basis. In the Nursery we have Shirley Powell, Lee Ames, Judy Rotondo, Karen LeBlanc and Janet Pantano on rotation, and Michele Skinner every Sunday. In the two and three-year-old group we have Katie Merrill, Lisa Lawson, Whitley Daly, Gail Fennessey and Eileen LaBrie. Judy Rotondo coordinated a schedule for baby sitting during the summer months of June and July.

The Board of Christian Education is grateful to all the teachers and workers who have made the Christian education of our young people possible. They are Dorothy Blanchard, Superintendent; the Rev. Southwick for the Senior High Class; Diane Townsend and Joe Rawlins, Junior High; Marion Harding, Fifth & Sixth grades; Shirley Southwick and Florence Hamelin, Third & Fourth grades; Cathie Southwick and Jane Kennedy, First & Second grades; Peggy Smith and Pam Boynton, Four & Five yearolds. We would like to thank our substitute teachers Tom Hamelin and Craig Southwick; also our P.F. Youth Group leader, Pam Feitz.

The Board treated the teachers to an Appreciation Dinner in June and in the fall we had a continental breakfast, after which there was a work shop to get ready for the new Church School year. Dorothy Blanchard's niece Karen Holly-Hebb shared her knowledge and her teaching experience with the Nursery workers.

The Church School offering from the first Sunday of each month is used toward mission projects. We had several projects which during the year. In February a candy sale was held to earn money for the "Kentucky Small Farm" Heifer Project. The farm consists of a pregnant pig (\$300), trio of rabbits (\$60), a colony of bees (\$30), and a flock of chickens (\$10), for a total of \$400. The candy sale netted \$161. In April we held a Covered Dish Supper, and asked the children to bring their favorite stuffed animals. Helen Snow made and awarded ribbons to the "biggest", "cutest", "prettiest", and "funniest" animals. From the free will offering, \$111.50 was collected to add to our farm project. With the addition of our Church School mission offerings, we were able to reach our goal.

November's mission project was collecting food and paper products for Emmaus House. Carolyn Boynton helped pack the food, and Pam Feitz, Trisha and Julie Chatterton, and Marion Harding took the collection to Emmaus. There were sixty-one bags of food and paper products which were gratefully received by the shelter. The December Mission project was providing toys for H.O.M.E. in Orland, Maine. It was great that Sister Lucy Poulin, founder of the H.O.M.E. mission, could be here that day to share a few of her thoughts with us.

This year we're emphasizing family worship, as we intend to do in the months ahead. Our Children's Day Program gives the older people in the Church a chance to find out what the young people have been learning in their classes every week. We want to thank Bob Knapp for leading a youth band for Children's Day and Homecoming Sunday.

Homecoming Sunday was a family worship day and also the first day of Church School. We brought the Church families together at the beginning of the service; the children were excused during the latter part of the service to get acquainted with their new teachers and classmates.

The first Sunday of Advent was also a family worship day, and the program which followed was a new adventure for us. "Journey into Christmas" replaced our usual Christmas party with a celebration of Advent, and the dedication of our toys for H.O.M.E. After the service, families gathered in the Vestry with their boxed and bag lunches; the Board provided beverage and dessert. We sang Christmas carols, and each adult and child chose an activity in which to participate. The workshops were: making the Jesse Tree, painting sand dollar tree decorations, making Christmas cards, making a creche, a demonstration on making wreaths, and doing tin punch wall/door decorations. Such a busy place! The afternoon ended with the reading of the Christmas story by Dorothy Blanchard. The figures of the creche were put in place by a child or adult as they were mentioned in the story.

Pam Feitz, with the help of Phil Southwick, have been keeping our Jr./Sr. Youth Group busy this past year. The Youth Group sponsored two dances at our Church, and participated in several more at area churches, including two area youth rallies. Other activities included a swim party, two paper drives, roller skating party, Plum Island beach day, program on drug abuse, and annual Wingaersheek picnic. They led the Easter Sunrise Service and served breakfast back at the Church. The group also prepared and served two meals at Emmaus House as their mission project. They are planning another meal in January.

We are proud of Jennifer Leigh who went on the Youth Mission Journey to Appalachia, along with other high school teens from area churches. They did trail maintenance, painted houses, and worked in the Blowing Rock Conference Center Thrift Shop. Our congregation appreciated hearing Jennifer's report about her experiences. What a good feeling to know we have young people who are willing to give of themselves to help others. Board of Christian Education

Our Church School building, Metcalf House, was refurbished in the fall. It looks much better with its new coat of paint and some siding replaced. The Junior High Class, under the guidance of Diane Townsend, raked leaves around the building and fall flowers were planted by the steps by a Board member and her family, making it a more attractive Church School home.

# School Superintendent

## REPORT OF THE CHURCH SCHOOL SUPERINTENDENT

"Study and be eager and do your utmost to present yourself to God approved, a workman who has no cause to be ashamed, correctly analyzing and accurately dividing - rightly handling and skillfully teaching - the Word of Truth." - 11 Timothy 2:15 - Amplified Version

The above is the goal of your Church School Superintendent and our dedicated Staff. As we strive toward this goal, we are constantly frustrated because there never seems to be enough time to do all we want to do. So, this year I am making a plea for all parents and other significant adults in our children's and youths' lives to join us in the above goal that the apostle, Paul, stated so well in his letter to Timothy.

How can you do this?

- Take time for spiritual growth in your personal life and in your child's life.
- Realize that 27 to 33 hours per year in Church School is only a beginning and insufficient time to receive an adequate and solid foundation for Christian Faith.
- Encourage regular Church School attendance to get at least this beginning. Make arrangements to get student leaflets for Sundays your student is absent. This can be done ahead of time or when student returns.
- 4. Follow-up Church School with your own at home Christian Education.
  - a. The students from Kindergarten (4 & 5 year olds) through grade 4 have weekly student leaflets that students should bring home. These give a clear indication of what the day's topic was. Talk with your child about the topic. Delve deeper together.
  - b. Periodically a letter to parents of the above group will be sent home, announcing the beginning of a new unit of study; so, there's a chance for some long-range parental planning.
  - c. Talk with your older children or contact their teacher to find out what they are studying and follow through.
  - d. Inquire about the reasons if your child is not bringing these papers home. Talk with your child. Then contact either the child's teacher and/or me to correct the situation.
- 5. Participate as a family in the Church School sponsored family activities. We tried something new this year as we substituted "The Journey Into Christmas" activity on the first Sunday of Advent for the usual Christmas Party. Our goal was to focus on the Christian celebration of Christmas. All families, who participated, also received a packet which gave suggestions for Family Advent Activities as well as for thoughts through the 12 Days of Christmas. We are planning a similar program for the Lenten Season on March 4.

## Superintendent's Report

Please feel free to contact the teachers and/or me if you have any questions or suggestions.

It is good for us at Baptism times to reconsider the promises made by parents and godparents to bring up children as Christians. We, as Church Members, make promises to support the parents in this goal. There are many facets to Christian Education and each person's unique talent is needed.

I appreciate the backing of all of our dedicated teaching staff whose names are listed in the Board of Christian Education's report. I also appreciate the support given us by the various Church Boards.

- 1. The Trustees have overseen, as well as helped in, the refurbishing of the Metcalf House exterior. I believe the Metcalf Family would now be proud of the building that bears their name. As one of the students put it so well. "Metcalf House now matches the Church". The Trustees also moved the small electric organ from the Church Vestry (gift of Harvey Chandler, now living in Ohio) to the 2nd floor of Metcalf House - a difficult task! We are using the organ for our Church School worship services.
- 2. The Finance Committee has "found funds" to help us buy new furniture and instructional resources and supplies.
- 3. The Diaconate has been supportive of our integration of Church School activities with the regular Church Worship services. They also have approved the expenditure of \$200 from the Memorial Fund to update our library for resources to be used by teachers, students, individuals and families. One-half the fund was used to purchase books related to Christmas.
- 4. The Junior and Senior Choir Directors and their musical groups have been most helpful when asked.

I really can't say enough about the backing given to me and to the Church School by the Board of Christian Education. Our special activities are made possible by their advance planning and active participation. These activities are described in the Board's report.

I am pleased to announce that we now have 86 Church School students. This is a gradual increase from the 70 we had three years ago. Our largest increase is in the Nursery and Pre-School classes. Boys seem to outnumber girls in many of the classes. Therefore, the Board of C. E. has made the suggestion that we enlist the help of class parents who would help on a rotating basis. Some of you will be receiving calls. Of course, we are always happy to hear from volunteers.

There are a few people to whom I would like to give special recognition. Thank you to the anonymous donor who gave us the colorful rug for the "orange room" in Metcalf House. The Barlow Family have donated a keyboard which we have placed in the Kindergarten Room; the pre-schoolers will have musical accompaniment. Joan Chatterton, our very capable Church Secretary, writes up special notices, creates eye-catching flyers and never is too busy to help.

## Superintendents's Report

Millie Gangloff has taken pictures at our special activities and has put them on display. Jay Hart and family painted the floor of the "orange room" in Metcalf House. They say we should now call it the Jasper Room! Craig Southwick and Tom Hamelin have served as substitue teachers. Tom has played the organ for us at the worship services in Metcalf House for Grades 1-4.

Karen LeBlanc inventoried all our library books at Metcalf House. Karen Magro has shared her artisitic talents in helping us to develop a new type of display on the bulletin board in the "long room". Charleen Maunsell planted chrysanthemums in the unyielding, hard-packed soil in front of Metcalf House. This was a great welcome back on Homecoming Sunday.

John Morrison, Lillian Pendergast and Jan Robertson retired after several years of conscientious teaching. Marjorie Stewart, retiring Board of Christian Education member, faithfully helps behind the scenes.

Shirley Southwick and Marion Harding help to keep the Metcalf House bulletin board changed. Phil Southwick listens to our problems and challenges and helps to resolve them.

We are again encouraging memorization of some of our Christian "Basics" i.e. the Lord's Prayer, 23rd Psalm, Doxology, Ten Commandments, The Great Commandment, etc. At this writing 4 members of the 3rd and 4th Grade Class have been honored for memorizing the Lord's Prayer. They are Megan Daly, Kerri Kennedy, Stephanie Longchamps and Jared Rollins.

A very special note of recognition is due to Marion Harding, the outgoing chairman of the Board of Christian Education, who has worked with all of us in leading the thinking through of the many details of our various special activities so they will "flow" easily. She and I have attended several Northeast Area Christian Educators' meetings and workshops, and have been inspired to be innovative.

# Mission Coordinator

## REPORT OF THE MISSION COORDINATOR

#### Emmaus, Inc.

Our cooks young and old have prepared six meals for the people at Emmaus House in Haverhill. The Youth Group were in charge of two of the meals this past year-God Bless you! In 1990 there are six meals planned for Emmaus House. If you would like to join the kitchen crew, give Estelle Passeri a call at 462-7966, our Diaconate liasion person for missions or leave a message at the church office.

On November 19 we celebrated Thanksgiving Sunday by collecting canned goods and paper products for Emmaus House. Trisha and Julie Chatterton Mrs. Feitz and Mrs. Harding delivered over 60 bags of groceries that afternoon. Last fall Crosby's advertised free turkeys for every \$400 worth of grocery receipts. Surprisingly there were enough receipts turned in for 9 turkeys. Good job.

#### Habitat for Humanity

About 20% of our Lenten offering which amounted to \$217.20 was donated to this project. A couple of years ago Mr. John Cuozzo, Vice President of the Lawrence Project, was our guest speaker. He explained that homes are built in partnership with low-income families all over the world. The materials are the most expensive part of completing this project. There are Habitat projects in Lawrence and Saugus. Funding from individuals, churches, corporations, foundations and other organizations are essential to making this program work. Their goal is to help low income with affordable permanent housing vs. temporary shelter.

When Habitat for Humanity began working overseas, organizers found that many local people couldn't pitch in because of vision problems. Eyeglasses are only for the well-off in many developing countries so Vision/Habitat was started. This year all the eyeglasses you donate will be sent to Vision/Habitat, Habitat and Church Streets, Americus, GA 31709.

## Heifer Project International

The Board of Christian Education in cooperation with the Sunday School Department raised \$400 to set up a small farm in Kentucky: a pregnant pig (\$300), a trio of rabbits (\$60), a colony of bees (\$30) and a flock of chickens (\$10). The monies were collected from a February candy sale, covered dish supper and the Sunday School collections from the first Sunday of each month. People pass on the first off-spring from their Heifer animal to another family in need and the gift of love goes on and on.

The cancelled postage stamps are still being collected and sent to a volunteer in Ft. Wayne, Indiana where they are sold to a local stamp dealer. Proceeds then go to Heifer Project.

## H.O.M.E.-Homemakers Organized for More Employment

During the year we have sent over 25 boxes of warm clothing to H.O.M.E. On December 3, Sister Lucy Poulin, originator of H.O.M.E. was our guest speaker during morning worship service. In the afternoon the Board of Christian Education sponsored a family advent workshop. When it was time for Sister Lucy to start back to Maine the Christmas presents were packed in her van. Without our support at this time, the children at H.O.M.E. wouldn't have had any Christmas presents.

#### Kidney Foundation

Pull tab rings from beverage cans are still being saved to purchase hours on a dialysis machine for victims of kidney diseases. For every 1,000 pull tabs, it's worth 1 hour of kidney dialysis. There is a collection box outside the church office for these pull tab rings and thanks to Millie Gangloff for delivering these to Eddie Howard's Boy Scout Troop 405 in East Derry, N.H.

As of January 1990, 250,000 pull tab rings have been collected. We are the largest contributor so keep them coming in!

#### Missionary Society

A small group of dedicated ladies meet a few times a year to keep The Women's Missionary Society going at our church under the direction of Mina Hartman. Please see their report for their contributions to various charities.

#### United Church of Christ

On April 30 an all church offering was taken for One Great Hour of Sharing which supports our foreign missions in relief and development work. On Oct 1 an all church offering for Neighbors in Need was taken to support our denomination's mission within our own country.

Due to the devastation of Hurricane Hugo and San Francisco Earthquake 20% of our advent offering was sent through our UCC to help the victims get back on their feet.

On June 30 Jennifer Leigh was one of 17 youth from the Northeast area to be part of a youth mission trip sponsored by the Northeast Area Youth Council. The group spent ten days in Blowing Rock, N.C. working with the underprivileged people of the area. Their days were spent cutting trees, painting houses, raking, working on trails and working in their Thrift Shop.

The Ladies Guild met on February 14 to work on projects for CWS and to make "comfort pillows". Sewing kits were packed for CWS. Also we were able to send to CWS handmade baby sweaters, baby afghans, 10 lbs. yarn, used blankets, and men's clothes. The project of the "comfort pillows" continued for the next few months and we made over 30 which were delivered to some of our special friends and to the hospitals in the area. On November 28 the Ladies Guild invited Linda Hastings from the Bradford Congregational Church to show some slides on the people making crafts for SERRV and see some of the crafts from around the wrold. SERRV is a non-profit marketing organization whose purpose is to promote the social and economic progress of people in developing regions of the world by purchasing and marketing their handcrafts in a just and direct-as-possible manner.

#### The Window

The Window serves as a collection and recycling center of various items for other organizations, both local and worldwide in their services. Due to the shipping costs for these items, we have limited the items we send to Indiana to plastic pill bottles, eyeglasses and postage stamps. The plastic pill bottles are sent to a medical missionary hospital clinic in Liberia, West Africa. The used eyeglasses are used by the VOSH-Indiana project in Central America. Proceeds from the stamps go to Heifer Project.

All year long there will be a box outside the church office for pull tab rings, eyeglasses, pill bottles + postage stamps. Please continue bringing in these items--they are needed!

Again, thank you for supporting our various mission projects.

### Renovation

### REPORT OF THE RENOVATION COMMITTEE

It is hard to believe that the first meeting of the Renovation Committee took place way back on December 15, 1985. Over the past four years the committee has wrestled with a myriad of possible improvements to our church structures, in an attempt to prioritize issues and formulate a viable approach our congregation could embrace.

At the January 1988 Annual Meeting, the Church authorized the committee to hire an architect to design a new addition on the rear of the church edifice. Over the following year an architect was selected, and the painstakingly slow process of design was initiated. The church grounds and buildings were surveyed. Months were spent reviewing different layouts, floorplans and schematic puzzles. A great deal of individual and group input was solicited from the Church body on items ranging from handicapped access, elevators, classroom requirements, Thrift Shop, storage and heating to "child height toilets" for the Church School. In the process, many revisions were made and construction cost estimates were secured.

Last January the schematic plans were finalized and colored renderings prepared along with a slide show and final cost estimates. At the January 26th Annual Meeting, Bob Knapp and Frank Stewart, with assistance from our architect, Arne Goldman, presented the preliminary plans for our Church's "New Vision". A four-month period was established to allow all interested Church members the opportunity to suggest changes, make recommendations and digest the importance and enormity of this major decision in our Church's histroy. During this period, the plans were displayed; several other complete presentations were scheduled for those, who were not able to attend the Annual Meeting, (with transportation provided) and opinions were diligently solicated from the enitre Church body by means of a mailed questionnaire.

In May the plans were revised to reflect many of the suggestions made and the addition was enlarged to accomodate more class room (meeting room) space. With careful thought and much publicity, we were summoned together on June 15th to the Special Church Meeting to vote on the proposed addition. Views of members and non-members were welcomed and written comments were read. Confideniality was assured by means of secret ballot. After much spirited discussion, the Church voted to authorize the Renovation Committee to obtain bids for the addition up to \$400,000, and contract for the work, with the final approval of the Finance Committee and the Cabinet.

Since June a complete "bid package" has been prepared by the architect for bidding and contractual purposes. The package includes detailed construction plans for each floor and a specification booklet detailing air circulation, electrical and mechanical systems, and a compilation of windows, doors and most exterior and interior fixtures and finishes. This fall, packages have been submitted to four independent, qualified contractors, including scheduled on-site meetings. Three contractual estimates have been received, with the fourth due momentarily (the estimates are time consuming and take contractors 30 to 60 days to prepare). Renovation Committee Continued:

Over the next few months, as the Capital Fund Raising Program takes shape, anticipated construction start and project implementation will emerge. We will also explore the timing requirements of the local permitting process and proceed as the need dictates.

A church project of this scope is neither funded nor constructed overnight. We will proceed in orderly fashion and will not "break ground" In the interim, until funding expectations have been met or exceeded. we will continue our separate program of ongoing church maintenance, in dealing with such items as the cosmetic plaster cracks, which have always appeared, as this old - but stately - wooden structure shifts in the wind. Separate accounts are targeted for individual items such as the heating system and continued maintenance.

We ask that the congregation maintain its patience and spirit as we take the necessary time to build the funding foundation for our new addition our "New Vision". As our forefathers struggled to rationalize the need and cost for the wonderful structure we have inherited, let us thank them for their commitment as we renew our own.
