#### Annual Church Meeting

#### February 3, 2002

The meeting was called to order at 11:35 AM by Moderator, Donn Chatterton. Rev. Leonard Zecchini opened the meeting in prayer.

<u>Article I</u>: To receive the reports of the several boards, committees and officers of the Church and to take action thereon;

Kristen Arsenault made a motion to accept the reports of the several boards, committees and officers of the Church; Bob Knapp seconded the motion. Donn spoke on the Annual Reports and how every year the writing gets better and better. Donn thanked Joan Chatterton and Isabel Gammon for their work in assembling the reports. Donn asked for any additional comments on the reports. The vote was taken and carried.

Article II: The hear and act on the report of the Finance Committee in regard to the 2001 financial operations and the 2002 proposed budget, or take any other action in relation thereto;

Allan Barlow made a motion to accept the report of the Finance Committee; seconded by Bob Watts. Allan spoke of the "Summary Page 1" and Line 21: Grand Total Receipts. It appears that we lost money however we paid the mortgage off in Nov/Dec of last year. Allan asked for any questions. Dorothy Blanchard indicated that she was very appreciative of the complete financial report this year. The question was raised as to why there was less money allocated this year for the minister. Allan responded that we hope to have a new, settled pastor by June. Are there plans for renovation to the parsonage? Allan responded that at this time seeds have been planted in that regards but plans are a long way away. Donn asked if there were any additional questions for Allan – none appearing, the vote was taken and carried.

Article III: To see if the Church will vote to authorize the Treasurer, with the approval of the Finance Committee to transfer money for the Capital Outlay Fund to the General Checking Account from time to time during the ensuing year, for the purpose of maintaining an equitable cash flow and of financing current expense operations, in the event that unrestricted receipts from stewardship, loose collections, donations and fundraising activities doe not meet needed expenditures, or take any other action thereto;

Chuck Davis made a motion to authorize the Treasurer, with the approval of the Finance Committee to transfer funds from the Capital Outlay Fund to the General Checking Account from time to time during the ensuing year, for the purpose of maintaining an equitable cash flow and of financing current expense operations, in the event that unrestricted receipts from stewardship, loose collections, donations and fundraising activities do not meet needed expenditures. The motion was seconded by Pat Barlow.

Donn asked for discussion in regards to this motion - none appearing, the vote carried.

Article IV: The hear and act on the report of the Nominating Committee, or take any other action in relation thereto:

Marion Harding made a motion to accept the slate of officers for 2002-2003 as recommended by the Nominating Committee. The list of officers to be elected was read. The motion was seconded by Allan Barlow.

The Moderator asked the Clerk to cast one ballot in favor of the Nominating Committees recommendation of officers for the ensuing year.

Article V: The hear and act on any other business and take any other actions, relative to the Church and its property, which may be brought before the Annual Meeting in accordance with the Bylaws.

Dorothy Blanchard said that she has had difficulty understanding the Budget as presented by the Finance Committee. She indicated that she had spent time with Allan Barlow and came away with a better understanding of the financial statements. Dorothy made a motion the budget requests for the next year be given to the Finance Committee by the 2<sup>nd</sup> Tuesday of November each year. The motion was seconded by Charles Blanchard. Allan commented on the motion and stated that before the Finance Committee does the budget for the year they need information from the prior year and pledge information for the ensuing year. Cooperation from Committee Chairs would also be helpful in this regard. Donn re-read the motion, asked for discussion. The vote was taken and carried. Donn indicated that we would try this for one year.

Home Tapin spoke at length on the importance of the Heritage of the Church and hoped that we could take better advantage of our heritage. He suggested that a copy of a book about the Church be given to potential members. Home indicated that the historical foundation of our Church is very important. He indicated that he would be willing to revise the history he had written about the Church. Donn thanked Homer for his comments. Beverly Knapp said that the Historical Society is very interested in information on the Church and would be willing to help out with this process.

Steve LeBlanc spoke on behalf of the Search Committee. In total, the Committee has reviewed some 90 profiles (44 men, 46 women). They have had some face to face interviews and a number of telephone interviews. At this time, there are 2 viable candidates. At the present, Steve could not give a time frame for when the process would be complete, however June does sound like a reasonable date for a new minister.

Various questions were asked of Steve....if the viable candidates were men or women, their age, whether they were married or single, would they need the parsonage. Steve reported that we are required to give the interim minister 2 months notice. Steve indicated that the identity of the candidate would not appear until candidates week-end.

Donn thanked Steve and the other Search Committee members for their work.

Bob Knapp spoke on behalf of the Renovation Committee and the pew cushion status. Bob made a motion that we amend the 1999 allotment of \$11,500 for purchase of pew cushions, to \$13,500 for the pew cushions. We have talked to a company in Kansas and they will be back in May to do measurements etc. The motion was seconded. At the present time the "Butt Fund" has approximately \$6,615.00 from contributions for pew cushions. Donn asked for additional comments on this matter. The vote taken and carried.

Dorothy Blanchard made a motion that the Finance Committee conduct a budget workshop at least one week before each Annual Church Meeting. The motion was seconded by Charles

Blanchard. Dorothy discussed the need for the congregation to understand the budget before voting on it at the annual meeting. Donn asked for discussion on this motion, the vote taken and carried. Donn indicated we would try this for one year.

Donn reported on the establishment of the Safe Church Council. The UCC is addressing Safe Church procedures – safety for all within the Church. Who has access to keys, knowing how to proceed in the event of a fire or an emergency, misconduct etc. Leonard spoke of this in a recent Church newsletter. The Cabinet has approved an Ad Hoc Committee and appointed the following as members; Pam Sheehan, Michelle Brock, Tom Hamelin, Tom Stewart, Brad Chute, Richard Aberman, Peggy Smith. These members will be meeting with the Interim Area Minister in February or March.

No additional business at hand, the meeting adjourned at 12:15 PM.

#### Special Church Meeting

#### September 22, 2002

The duly called Special Church Meeting was called to order at 11:25 AM by Moderator, Donn Chatterton.

Donn thanked eleven very special people who have worked diligently over the past three years. Steve LeBlanc, Allan Barlow, Kirsten Davis, Donn DeSisto, T. Louis (Bud) Hamelin, Marion Harding, Paula Martel, Claudia Smith, David Smith, Susan Stead, and Diane Townsend were each introduced to the Church membership and received a standing ovation from their Church family.

<u>Article I:</u> To hear and act on the report of the Pastoral Search Committee, or take any other action in relation thereto;

Steve LeBlanc made a motion that the Church Membership vote to accept the report of the Pastoral Search Committee. The motion was seconded. Steve reported for the Search Committee and indicated that the committee had reviewed some 130 individual profiles. He indicated that he hoped everyone had received the letter with the profile information for Rev. Eric Marean. There are five churches in Massachusetts and New Hampshire who have expressed interest in having Eric serve as their settled pastor. Eric has expressed interest in our Church.

Donn asked for discussion in regards to this motion – none appearing, the vote was taken and carried.

Article II: To see if the Church will vote to call the Reverend Eric Marean as its Pastor and Teacher, or take any other action in relation thereto.

Steve LeBlanc made a motion that the Church Membership vote to Call Reverend Eric M. Marean as its Pastor and Teacher as authorized by the Constitution and Bylaws, Paragraph 4.4.1a). The motion was seconded.

Donn indicated that we would take the vote by secret ballot. The tellers (JoEllen Fielding, Karla Szkutak, Dwight Southwick, Kristen Arsenault, Ruth Jones) will collect the ballots and count them. The tellers reported that unanimously, the Church voted to Call Rev. Eric Marean as their pastor/teacher.

With much excitement, ovation and celebration, Steve LeBlanc brought Eric and Sara back into the Sanctuary and introduced Rev. Eric Marean as our new, settled minister. Eric spoke briefly, accepting the position and said that from day one, he knew that this was going to be the Church he had been looking for.

The meeting adjourned at 12:00 PM for cake and coffee in the Fellowship Hall.

#### Special Church Meeting

#### October 20, 2002

The meeting was called to order at 11:40 AM by Moderator, Donn Chatterton.

Donn read the Church By-laws as pertaining the Church and its property. Donn reported that the new minister will seek to find independent housing.

The Warrant was read by the Church Clerk.

Article I: To see if the Church will vote to authorize the Board of Trustees to sell the Parsonage, located at 5 Hart Circle, Georgetown, MA, in accordance with paragraphs 4.4.1c) and 4.4.10a) of the Constitution and Bylaws, and to direct the Treasurer, with approval of the Finance Committee, to invest the proceeds of the sale in a special pastoral housing account, to be selected by the Finance Committee, for the purposes of:

- 1. Maintaining a Pastoral Housing Fund in the event there is a need to purchase a parsonage or help a pastor purchase housing in the future;
- 2. Using the earnings form the account to offset the Pastor's housing allowance and to grow the account principal in accordance with the Church investment policy.

A motion was made by Steve Pinto as to the above, motion was seconded by Allan Barlow. Donn asked for any discussion –

Allan indicated that every member should have received a letter about this matter. Tom Stewart said that this seems to be a wonderful "business move", however we have a family in crisis in our Church who needs housing. Tom made a motion to delay the sale of the property for one year, to allow the family in crisis a place to stay. Donn indicated that the Cabinet has spoken about this family and their situation. Donn asked if anyone from the Cabinet wished to speak about this. Bob Knapp said that substantial work needs to be done on the parsonage to bring the property up to a livable standard. The Cabinet wrestled with this situation and we are people of faith, however the Cabinet felt that we could best help this family with assistance in other ways. This was a very difficult, and thought provoking decision for the Cabinet. Jim Callahan said that the Cabinet had met with an attorney and based on information passed on at that meeting, added to the decision of the Cabinet. Ralph Turgeon spoke that it was his family that was having a housing crisis. He said that this Church has been a family to them, however he wants the Church to do what is best for the Church.

Helen Snow thought that we should hang on to the property and obtain a mortgage and possibly invest the mortgage funds. Joan Chatterton said that we as a congregation have put very little into the parsonage of the years. Maintenance was not expended. Things that had been promised to Phil Southwick and family were not followed through, and they never complained. Shame on us a congregation, now we are faced with a house with a lot of problems.

Donn indicated that an adjustment to the motion would not be made. The vote was taken, tellers tallied, the vote carried.

Donn thanked Ralph Turgeon for his words and thanked those who spoke as well.

Allan Barlow made a motion that the Church vote to treat the Pastoral Housing Fund as though it were real property meaning that expenditures or loans from its principal must be authorized by vote of the Church Membership per paragraph 4.4.1c) of the Constitution and Bylaws. The motion was seconded.

The Pastoral Housing Fund – the proceeds will be invested as if it were still real property. The funds would be "locked up" as if it were a parsonage without the maintenance. The Finance Committee would like to know of any ideas of obtaining high rate of return.

Donn asked for any additional discussion – none appearing, the vote taken and carried unanimously.

Karla Szkutak made a motion that the Church vote to authorize the Treasurer, with the approval of the Finance Committee, to expend that portion of the Pastoral Housing Fund earnings designed by the Church Investment Policy for its Endowment Funds, to grow the Pastoral Housing Fund principal, and to expend the remainder of the Pastoral Housing Fund earnings to help offset the Pastor's Housing Allowance. The motion was seconded.

Karla spoke of the AG Edwards representative who has been most helpful and said she is looking for any ideas on high return.

No additional discussion - the vote taken and carried.

No additional business at hand, the meeting adjourned at 12:10 PM

## Report of the Interim Pastor January – November 2002

The first annual report I made to you in January 2000 shared some of the thoughts I had as your then-new Interim Pastor. Neither you nor I knew what we would be going through together, or for how long, as we proclaimed Jesus' Good News of salvation (healing, wholeness, and fulfilling life) to ourselves, our families, our community and to the various worlds each one of us interacts with as we go about our daily activities.

In addition to the typical activities as a settled pastor does, there are several tasks that are now generally accepted as being part of an interim pastor's responsibility to encourage during the time of transition from one settled pastor to another.

One is coming to terms with the history of the congregation. Included in that is not merely dealing with the loss of a valued retired pastor such as Phil Southwick but also considering the formative history of the church in the past. In our church membership class we had Dorothy Blanchard's assistance as we looked at how this parish fit into the general religious scene since the early days of the settling of New Rowley. Part of the heritage of this parish were the dissentions in the nineteen century which brought about the formation of the Memorial Church by those who had difficulty with South Church. But also part of this heritage was the healing of that rift by the unification of those two congregations to form First Congregational Church.

Another task during the interim period is allowing needed leadership change. This was not too a pressing issue as this congregation has had a tradition of the laity taking responsibility in guiding the church in its mission. Having a pastor not living in the community and not engaged in the parish full-time possibly encouraged various boards and committees to function in different modes than they were used to when Pastor Phil Southwick was present and just around the corner. Not having Phil's longevity of knowledge and experience with you and your concerns I tried to be a supportive presence to the various boards and organizations that make up this Body of Christ.

Another task is discovering a new identity. In one annual report I mentioned that there would be a period of adjustment in coming to terms with the realization that Phil Southwick was no longer pastor after an incumbency of thirty-four years. New ministry cannot really begin until we are ready to release the past. As an interim pastor I had no mandate to pursue a particular direction of ministry other that which comes out of my own background, theological orientation and church experience. The Diaconate when fulfilling their task of securing an interim pastor did not have the luxury the Pastoral Search Committee has had in interviewing the congregation to determine what characteristics are most appropriate in a new pastor. I was here for a limited time and had a limited mandate such as dealing with the Interim Tasks.

The other interim task is that of committing to new directions in ministry. You have only to look around and see where you are with that. In the pastor's office is Eric Marean. Eric and Sara you have, after great deliberation and search, brought from a great distance (for New England) to minister with you as you live out your life together as this particular manifestation of the Body of Christ.

Ruth and I are so very grateful for your gracious reception of us during the time we were with you. May you all faithfully proclaim Jesus' Good News, and be Good News, in a world that desperately needs Good News!

#### Report of the Church Clerk

In the year 2002, the activity level of our Church never seemed to falter. Many new and exciting things were on the horizon at the start of the year. Boards and Committees were hard at work, organizing and reorganizing themselves. The Search Committee comprised of 11 hard working, dedicated individuals were spending many Monday evenings listening to candidates tapes, doing phone interviews, and going out into the field to search for our settled minister. Back at home, the Renovation Committee was working to order new pew cushions for our sanctuary and the Safe Church Council was beginning to form their ideas to make our Church home a safe, protected haven for all of us. In addition to our own Church sponsored groups making use of our facilities (Sunday School Classes, Youth Groups, Music Groups, Ladies Guild), there are many outside groups who meet regularly in our building. Georgetown Council for the Aging, Boy Scouts, Girl Scouts, TOPS, AA, Joyce Dance Studio, Royal Stage Ensemble, and Moonlight Productions all make their presence known within the walls of our Church.

In mid-August, I received a telephone call from our Moderator, indicating that the Search Committee was ready to present a Candidate to the Church Cabinet. In a flurry of excitement, all Committee Chairs received late night phone calls requesting them to attend a special Cabinet meeting the next evening. With representatives from all Boards and Committees in attendance, the Cabinet voted to accept the Search Committee's recommendation of their candidate (Rev. Eric Marean) and established a Candidates weekend in September for the Church family to meet Eric and hear him preach in our pulpit. With much excitement, the membership voted unanimously to Call Rev. Eric Marean as their full-time, settled minister.

The fall of 2002 brought a renewed sense of excitement as we awaited the arrival of Rev. Eric Marean and his wife Sara to our Church and community. The fall also brought a time of closure with our Interim Minister, Rev. Leonard Zecchini. During Leonard's interim stay with us, he worked hard to prepare us for the transition to our settled minister. We appreciate his dedication and willingness to see this congregation through this interim period of three years. We wish Leonard and Ruth well in their new interim position in NH. #### BOARD OF CHRISTIAN EDUCATION 2002 ANNUAL REPORT

This year has been an exciting, if somewhat challenging one for the board, as there was a change in chairman after the beginning of the year, as well as of course, the transition to a new minister at the end of the year. Along with these changes, is the national growing concern regarding the safety of our children (and adults) within the church environment. The Board will continue to work with the safety committee to address these issues as well as to pursue our more traditional activities, in order to continue to provide a sound Christian Education for our youth. The board would be remiss if we did not take this opportunity to thank our teachers (and high school assistants) for the time and energy they devote to teaching Sunday School. The willingness on the part of our congregation to volunteer their time and share their faith is truly heartwarming. Other accomplishments are outlined below:

Missionary Work: Participated in the Thanksgiving and Easter Food drive for Emmaus House. The annual Heifer Project raised over a thousand dollars and purchased the "Milk Menagerie" which consisted of one heifer, two goats and a water buffalo.

Curriculum: A new UCC curriculum called <u>Seasons of the Spirit</u>, (put together by a Protestant interdenominational group, Productions Inc.), is being used for the 7<sup>th</sup>-8<sup>th</sup> grade students. Christmas Concert: Approximately 80 people attended the third annual potluck dinner following the beautiful and varied music concert.

Star Island: Scholarship fund sent 2 families and 4 teens to Star Island for various week long summer conferences.

#### REPORT OF THE WOMEN'S GUILD

Our Women's Guild is quiet during the cold and slippery months of January and February. Traditionally we resume meetings at the end of February when we have work parties for missions.

Our work parties in February and again in March 2002 were for the purpose of tying quilts and rolling pennies for Church World Service. A total of \$512 was raised in 2002 making possible the purchase of over 100 blankets for refugees! At least twelve quilts were completed, thanks to the leadership of Millie Gangloff, who continues to coordinate our efforts on behalf of quilts sent to critically ill babies and toddlers. (The last shipment of quilts were brought to Boston hospitals and given to poor women who had very little for their newborns; their babies were considered "at risk".) For our friends in North Carolina, we prepared Easter boxes containing such goodies as: special tea, honey, candies, angel pins, and small books.

Thanks to Helen Boynton and Mina Marble who represented our Guild at the Annual Spring Meeting of the Essex Women's Association held this year at the Rowley Congregational Church, April 24<sup>th</sup>.

The highlight of our Guild year was the Spring Social held Friday, April 26<sup>th</sup>, with invitations sent to seven area churches. The response was wonderful! We had seventy people in attendance to hear Donna Marion Titus who gave a dramatic impersonation of Celia Thaxter, Isles of Shoals poet, writer, artist, and horticulturist who lived on the islands from 1835-1894. Thanks to all who donated goodies and money to help with the refreshments.

The Luncheon for the Blind was held on Saturday, May 18<sup>th</sup>. Several of us prepared and served our guests and Charlie Locke's group played the "oldies" for an appreciative audience. The Blind Guild gave us a donation for our efforts that we will use for quilting materials.

Our fall programs began in September when we were happy to honor one of our own! In a special afternoon tea program, the Georgetown Historical Commission presented Olive Cole with the Boston Post Cane in honor of her being the oldest citizen of Georgetown. In addition, the Historical Commission representatives gave an informative talk on the history of the Boston Post Cane. Many guests from the community were in attendance.

In October we were delighted to welcome Jim Boynton as guest speaker. His rendition of "School Daz Two" was a sequel to "School Daz" at which time he continued his stories of his experiences as long-time principal of Georgetown High School.

The year rounded-out with a super luncheon party hosted by Nat Tidd at her home the beginning of December. It was a wonderful way to begin the holiday season. We were honored to have two guests at that luncheon – our new Peabody Library Librarian, Ruth Eifert, and our newly settled Minister, Eric Marean. Ms. Eifert gave an interesting overview of the library offerings.

We welcome all churchwomen to Guild meetings. They are informal and friendly and meaningful in the work we do. Please join us!

#### REPORT OF THE MISSIONS COORDINATOR

One of the best things about our church family is the caring, supportive way everyone reaches out to help others whenever there is a need. All of the different committees - Diaconate, Church School, Women's Guild, both Youth Groups, etc. - report on their own particular contributions, so this report is just a brief sampling of the various missions that are touched by the generosity of our congregation.

This past February the sum of \$261.25 was raised from the Valentine's candy/crafts sale, which went towards the purchase of a heifer for a Romanian orphanage. In addition, the Church School collection taken on the first Sunday of every month has been designated for that same purpose.

A member of the Diaconate (this year Janice Murphy did a super job) organizes and recruits church families to prepare meals for Emmaus House on a monthly basis. Items dropped off in our food pantry are delivered to Emmaus, and our Thanksgiving food offering was delivered to them by our Middle School Youth Group. A monetary donation went to their "Everybody Matters" capital funds campaign, helping them to complete a new shelter.

Each year we collect Christmas gifts for the children at H.O.M.E. in Orland, Maine. Over 100 children were thrilled to receive gifts at their annual Christmas party. We received a thank you note from Erin Smith, the young lady who came with her husband to pick up the presents. She wrote "You have given families hope that there is good in the world", which shows us how much our gifts were needed. On top of that, after reading in a newsletter that H.O.M.E. needed a van, one of our church families very generously donated *their* van to the cause!

The Guild is always busy with one mission project or another. This year they raised \$512 in pennies, which will be used by Church World Service to buy warm blankets, sent Easter gifts to their "pen pals" down in North Carolina, and made 15 quilts for babies suffering with AIDS in the Boston area.

Two special offerings are taken for the United Church of Christ outreach programs, one in the spring, one in the fall. The "One Great Hour of Sharing" offering is designated to support missions throughout the world. The "Neighbors in Need" offering helps people here in the United States.

Our church's Diaconate Fund is used to assist local Georgetown families as needed. The money in this fund comes from endowments and donations. The Fund was supplemented by 20% of both our Lenten and Advent offerings, the amount which is traditionally earmarked for missions.

Church families are asked to make their personal contributions to missions through the church treasury. Checks can be made payable to the church with a memo noting the specific mission. The church records will then show how our congregation really makes a difference when we pool our resources.

Thank you to everyone for your support of these missions!

## REPORT OF THE SAFE CHURCH COUNCIL

The more things change, the more they remain the same. Who would have known they could have been talking about the Safe Church Council. We have been charged by the Cabinet to bring our church up to date regarding Safe Church policies and procedures that have been recommended by Massachusetts Conference of the UCC. While some of the changes are very similar to the policies we experience in are own jobs, many will be quite different. Examples include Fire Evacuation Plans as well as Incident Reports. Often, these are taken for granted when it comes to work or school but they eem to be forgotten at church.

Throughout the year, our committee has been discussing the various policies and procedures currently in use and some that have never been used before. These include, but are not limited to, building security, teacher training, volunteer applications, and insurance liability. During the next year, you will begin to see the results of our review as we start to implement one policy at a time. Some new policies will be developed, while others will be modified from the documentation we have received from the seminars our members attended at the Andover-Newton Theological School. We are also using information from policies and procedures that have already been implemented at other Massachusetts conference churches.

The church facility is the first focus of our group's effort, as we'll be starting with building security. The Key Policy and Emergency Protocols will be our first policies to be implemented within the coming year. It was a mostly uneventful year for the Renovation Committee. Now that Rev. Marean has become our settled pastor we are re-exploring possibilities for our church structure and property. We will be meeting with an architect early in 2003 to help us understand our options.

Thankfully we were able to find a company, Waggoners, Inc. of Hutchinson, Kansas, to produce new pew cushions for us. We met with their representative, Calvin Lambert, in February and learned more about foam and pew cushion manufacturing than we thought possible. After we had made our materials selection Mr. Lambert returned in May and measured everyone of our pews and placed our order. On an evening in August the Waggoners van pulled up to the front door of our church and the husband and wife team, who were delivering cushions throughout the New England area, unloaded (with a little help from us) & placed the cushions onto their correct pews.

We are now the proud owners of 93 3" thick high resilience foam mitered-circular pew cushions with Dacron wrap covered with "night blue" Murios upholstery fabric treated to meet all Massachusetts fire laws. We also have an additional 4 yards of fabric should we need it for any reason.

As it turns out, we were fortunate our original manufacturer backed out as we now have a much better cushion at only a slightly higher price. (\$12,512.00) We include a special thanks to all who contributed to the "butt" fund.

After the members of the church band had the pleasure of throwing the old cushions out of the church windows into the back parking lot the new cushions were "specially blessed" on rally day.

Hopefully these will bring years of comfort to all who use the sanctuary.
