Minutes of the Annual Church Meeting

Sunday, February 1, 2004

The meeting was called to order at 11:30 am by Moderator, Donn Chatterton. A motion was made to accept the minutes of the 2003 Annual Meeting. The motion was seconded, discussion called for and the motion carried.

Article 1; To receive the reports of the several boards, committees and officers of the church and to take action thereon;

A motion was made to accept the reports of the several boards, committees and officers of the church and to take action thereon: The motion was seconded. Discussion – Donn thanked all those who compiled the reports – the reports are very well written and well phrased! The motion to accept the reports carried.

Article II: To hear and act on the report of the Finance Committee in regard to the 2003 financial operations and the 2004 proposed budget, or take any other action in relation thereto:

A motion was made that the Church vote to accept the 2003 Financial Report and 2004 Budget with the corrections as reported verbally. The motion was seconded. Discussion: Allan reviewed the various items – Line 37, page 7 to \$106,580; Line 47, page 7 to \$9,670.14;, Line 51, page 7 \$193,493.53; Line 54, page 7 to –4,179.14. The motion carried.

At this time the Audit Committee reported and a motion was made to accept their report – the motion was seconded, discussion called for and the motion carried.

Article III: To see if the Church will vote to authorize the Treasurer, with the approval of the Finance Committee, to transfer money among the various accounts from time to time during the ensuing year, for the purposes of maintaining an equitable cash flow and of financing Current Expense obligations.

A motion was made that the Church vote to authorize the Treasurer, with the approval of the Finance Committee, to transfer money among the various accounts from time to time during the ensuing year, for purposes of maintaining an equitable cash flow and of financing Current Expense obligations. The motion was seconded. Discussion: The question was asked if there is a conflict of interest with the Treasurer making the transfer of funds. Allan Barlow responded that the Treasurer must of the vote of the Finance Committee to make the transfer. The motion carried.

Article IV: To hear and act on the report of the Nominating Committee, or take any other action in relation thereto;

A motion was made that the Church vote to elect a slate of Officers, Boards, Committees, coordinators and Auditors listed in the Nominating Committee's Report on page 16 on the Annual Reports 2003, and that to signify such election, the Clerk be directed to cast one ballot in

favor of the slate as presented. The motion was seconded – discussion – the Clerk cast one ballot in favor of the slate of officers.

Article V: To see if the Church will authorize the Finance Committee to negotiate the sale of the Rio Rancho, New Mexico property, and further, to authorize the Chair of the Finance Committee and the Chair of the Trustees, with the approval of the Cabinet, to act for and on behalf of the Church Membership in the execution of said sale, or take any other action in relation thereto:

A motion was made that the Church vote to authorize the Finance Committee to negotiate the sale of the Rio Rancho, New Mexico property, and further, to authorize the Chair of the Finance Committee ad the Chair of the Board of Trustees, with the approval of the Church Cabinet, to act for and on behalf of the Church Membership in the execution of said sale. The motion was seconded. Discussion – Allan explained to the Church how we were given the property in New Mexico and indicated that it is approximately 1 acre valued at approximately \$3 -\$4,000. It is not far from an Indian Reservation. The motion carried.

Article VI: To see if the Church will vote to authorize the Trustees to negotiate with suitable firms for the lease of the Church edifice bell tower, attic, and other space required for installation, operation, and maintenance of wireless transmission and receiving equipment, provided that such action does not result in any planned disruption of Church activities, obvious alteration of the edifice external appearance, or any unsolvable personnel or property safety issues, and further that regular monetary receipts received in exchange for the lease privilege be intended for mission projects, supplementation of Church Endowment Funds, and/or facility improvements, or take any other action in relation thereto.

A motion was made that the Church vote to authorize the Trustees to negotiate with suitable firms for the lease of the Church edifice bell tower, attic, and other space required for installation, operation, and maintenance of wireless transmission and receiving equipment, provide that such action does not result in any planned disruption of Church activities, obvious alteration of the edifice external appearance, or any unsolvable personnel or property safety issues, and further that the Chair of the Trustees and the Chair of the Finance Committee, with the approval of the Cabinet, be authorized to act for and on behalf of the Church Membership in the execution of said lease, and further that regular monetary receipts received in exchange for the lease privilege be intended for mission projects, supplementation of Church Endowment Funds, and/or facility improvements. The motion was seconded. Discussion - Chuck Davis explained the general scenario of conversation with Yankee Tower who act as brokers for various cell phone companies. The lease does not have any guarantee that we would receive any revenue and we would be bound to the lease for 5 years. The revenue would not affect our non-profit status. When the equipment is removed, they must put our facilities back as they found them. The question was asked about health issues - Chuck replied that there were no specified health issues. Nancy Aberman agreed with that statement based on research her library had done for cell tower use. Chuck spoke of obtaining references on Yankee Tower and that this company would provide their own liability insurance, so it would not affect our insurance. The question arose that it was felt that the Church membership should have say in this decision rather than the Cabinet. It was mentioned that the Cabinet are your representatives – it was then asked that this Article be tabled until more information could be presented.

An amendment to the Article was made: A motion to amend Article VI to read as follows: That the Church vote to authorize the Trustees to negotiate with suitable firms for the lease of the

Church edifice bell tower, attic, and other space required for installation, operation, and maintenance of wireless transmission and receiving equipment, provided that such action does not result in any planned disruption of Church activities, obvious alteration of the edifice external appearance, or any unsolvable personnel or property safety issues, and further that the Chair of the Trustees and the Chair of the Finance Committee, with the approval of the Church Membership, in the execution of said lease, and further that regular monetary receipts received in exchange for the lease privilege be intended for mission projects, supplementation of Church Endowment Funds, and/or facility improvements. The amendment to the motion was seconded. The vote on the amendment carries. The vote then carried on the amended motion.

Article VI: To hear and act on any other business and to take any other actions, relative to the Church and its property, which may be brought before the Annual Meeting in accordance with the Bylaws, or take any other action in relation thereto.

At this time during the meeting, Moderator Donn Chatterton was recognized for his many years of service as our Church Moderator. We was presented with a sundial for his garden and also his name has been inscribed on the wall plaque in the Fellowship Hall. Donn received a standing ovation from the Church membership.

A motion was made to adjourn the meeting at 12:20 pm, seconded and carried. Everyone was invited to the Fellowship Hall to congratulate Donn Chatterton, and enjoy cake and goodies!!

In conclusion, I would like to express my gratitude to the faithful members of our church staff. Thank you Joan Chatterton, Emily and Bob Knapp, and Sharon Smith. Thank you also to the many volunteers who contribute to the health of this church—everyone named specifically in our weekly bulletin and everyone else who would be, had we the room.

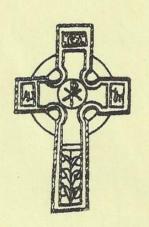

BOARD OF CHRISTIAN EDUCATION ANNUAL REPORT 2004

Another year has come and gone, and once again the board has been busy planning and organizing traditional activities as well as suggesting some changes. The board spent considerable time revising our policy booklet, which was last updated in 1985. Copies of the booklet are available in the church office. The board wanted to create more intergenerational opportunities for the congregation to enjoy and strengthen our community of faith. A potluck supper/game night was well received and the board plans to continue this next year. Another opportunity was provided by the Christmas craft and caroling party which was enjoyed by parents and children. Children continue to participate in the beginning of worship and enjoy a children's message given by Eric. On communion Sunday the children come to the end of worship in order to participate. Many teens continue to remain connected to the church school by assisting in the classrooms and nursery as well as involvement in youth groups. They also enjoy opportunities to participate in the adult worship service through band, choir and lay readings. Once again, the board has been privileged to work with a wonderfully dedicated group of teachers, high school assistants and nursery caregivers. These teachers spent precious time becoming familiar with a new curriculum (once again!) and organizing various activities. Jamie Krenn and her nursery school staff work hard all year round in order to provide young couples an opportunity to worship together. The board would like to thank each and every one for their time, energy and dedication spent on the young members of our congregation.

Listed below is a summary of the Board's activity for this past year.

- Rally Day started our season off with an intergenerational worship service led by Eric.
- The Star Island Scholarship fund used \$1,000 to assist 6 individuals (1 family and 3 teenagers) with attending the summer conferences at Star Island. In addition, several other members of our congregation returned to Star Island for the peace and special sense of community it offers.
- In April the board held their first annual potluck supper and game night with great success.
- \$2,500 in Church school mission funds sent to Heifer, Inc.
- At the end of the year the board acknowledged important milestones in the life of some of our children and young adults. Bibles were presented to everyone in the confirmation class, while 3 graduating HS seniors received a cross pin and card. Both received best wishes and success for the future.

- 4. Our annual Valentine Heifer Candy sale was another great success and allowed us to send two camels to Tanzania, plus a "milking group" of animals to a Romanian orphanage from funds that were raised the previous year.
- 5. We had a successful and fun Holiday Craft Workshop. We hope to make this an annual event. Thanks to all the teachers and students who worked to make this a success.
- 6. I would especially like to thank Jaime Krenn and all the nursery caregivers. Jaime does an amazing job of keeping the nursery staffed and clean. All our caregivers are dedicated and caring.

Concerns

In looking over the reports for the last few years, our concerns seems to remain constant.

As always, the conflicts, decisions, and choices that families have to make are a concern and greatly affect attendance. We have over 120 students registered in our Church School, but most Sunday's attendance is 40-60% of this. I again ask parents to talk to the sports organizers and advocate for practices and games to be held later in the day if they must hold them on Sundays. Sports and other activities are important, but again, parents shouldn't have to choose between sports and Church School. When children are absent, parents may pick up a copy of any Sunday's lesson from their child's teacher.

Annual Report of the Board of Trustees Year 2004

The First Congregational Church of Georgetown continues to be a vibrant center for worship and the community. There is at least one group in the building every day of the week during the school year. We presently host on a regular basis, Boy Scouts, Girl Scouts, Cub Scouts, TOPs, AA and other groups on a periodic basis. During this year there were wonderful performances by Royals Stage Ensemble and Moonlight Productions, and they are on the schedule again for 2005.

There were no major crises or projects during the year, though we did have to spend funds greater than our budget to upgrade our boiler to meet new state safety codes, and to repair the sprinkler system in the new section of the building. Insurance was also a major adjustment this year with costs increased dramatically. We will continue to look for ways to save money while continuing to support the ongoing activities and programs. To this end we ask everyone using the building to help contain our costs by insuring that lights are off and any appropriate thermostats are turned down prior to leaving the building for the evening. Last year we spent nearly \$16,000 in utilities (almost 10% of the total church budget).

The landscaping in the front of the building was updated after the digging from the church lighting project. Our gardeners, Jamie Krenn and Michelle Brock, did a great job with the planting and flowers along with assistance from the Georgetown Country Gardeners. The trustees will continue to improve the exterior lighting and safety of the building during the coming year.

We were fortunate to be able to acquire, free of charge, some great office furnishings. Once the Trustees picked up these items, they were distributed throughout the building. We are still finding homes for a few remaining items.

Our Sexton, Sharon Smith, continues to do a great job keeping the church clean, and we thank her for her hard work. Chris and Alex Pinto worked diligently throughout the year mowing the lawn and removing snow on a voluntary basis. This effort saves the church considerable expense. Ralph and Christina Turgeon cleaned at the church on various occasions. John Face again removed our leaves. His voluntary contribution is greatly appreciated.

Clean Up Day, held in April, was a success. We had many volunteers including a large contingent from the Boy Scouts. In addition to the normal exterior debris removal, the Boy Scouts patched the holes in the walkways and planted grass over the filled trenches. Much of the winter dust and dirt was removed.

I would like to extend my appreciation to fellow Board members: Steve LeBlanc, Bob Watts, Mike Lee, and Alan Gould. They have put in countless hours during the year. Additionally, Tom Hamelin always volunteers for that "odd job" and takes care various items as they arise.

Thank you to everyone who contributed to the many missions this church supports. Our outreach touches people in our own community, as well as throughout the United States and abroad. Some of our mission projects include:

- 6.8% of our weekly pledges went directly to the Massachusetts Conference UCC for funding outreach programs
- charitable donations to help victims of the Florida hurricanes and the recent tsunami in Southeast Asia
- the Valentine's Day candy/craft sale raised over \$400.00 for Heifer Project International, to help purchase camels for transportation in Tanzania, as well as milking goats and cows in Romania
- 20% of our Lenten offering went into our Diaconate Fund, specifically designated for local needs
- donations of books, paper, crayons were sent in school bags to school children in Iraq/Afghanistan (through Church World Service)

- 20% of our Advent offering was designated to support the Good Neighbor Energy Fund run by the Salvation Army
