Article IV: To hear and act on the report of the Nominating Committee, or take any other action in relation thereto;

Article V: To hear and act on any other business and to take any other actions, relative to the Church and its property, which may be brought before the Annual Meeting in accordance with the Byławs, or take any other action in relation thereto.

Annual Meeting 1-27-08

The meeting was called to order at 11:33 AM by Moderator Pro-Temp, Allan Barlow. Pastor Eric Marean led us in an opening prayer.

Allan indicated that he would dispense with the reading of the Warrant Articles during the meeting. If you wish to speak, please raise your had and an usher will provide you with a microphone. Please sign the attendance sheet that is circulating around so we know who is in attendance at the meeting.

Nominating Committee reports and Budget motions for 2002 were distributed to everyone to have access to during the meeting. Allan indicated that the Cabinet had appointed him Moderator Pro-Temp for the Annual Meeting.

Article I:

Marion Harding moved that the Church vote that accept the 2007 reports of the several Boards, Committee and Officers of the Church. The motion was seconded. The Moderator Pro-Temp asked for discussion. The Clerk indicated that on page one that it was intended that it be the Warrant from the 2007 Annual Meeting. Copies of the 2007 Warrant are available if anyone wishes to swap out that page. Also, on page 2 of the Clerk's report, the last word on the page should read "carried" not "varied".

The Moderator Pro-Temp asked that the Annual Reports be accepted as amended – the motion carried.

Article II - two motions -

Bob Knapp moved that the Church vote to amend the motion approved by the Church at the Special church meeting of October 20, 2002, establishing the Pastoral Housing Fund as real property by changing "its principle" to "the initial amount of \$260,000.00". The motion was seconded and Allan asked for discussion. Bob explained the motion – in 2002 the funds from the sale of the parsonage were taken and endowed – meaning that these funds could not be touched except by Church vote. The total amount came to \$260,000 which is why the Finance Committee asking for this motion to be amended. How much is in the fund at the present time? \$315,000 at this date in the fund. This requires a 2/3 vote to pass –

The vote taken – the motion carried by more than a 2/3 majority

Motion 2 under Article II – Bob Knapp moved that the Church vote to amend the motion approved by the Church at the Special Church Meeting on October 20, 2002 establishing the procedure for handling the proceeds from the Pastoral Housing Fund by changing the phrase "...to expend the remainder of the Pastoral Housing Fund earnings to help offset the Pastor's Housing Allowance" to "...expend the remainder of the Pastoral Housing Funs earnings <u>first</u> to help offset the Pastor's Housing Allowance and then to supplement the Reserve Fund to make up for any current expense deficit". The motion was seconded.

The Moderator asked for discussion – Bob Knapp explained this motion. Funds were taken from various accounts. This has left us with \$15,0000 in reserve to start out the 2008 year. In the budget for 2008 – we have a 40-50 K deficit. Housing Fund at this time is the best choice of where funds can be tapped – the Finance Committee would like to be able to tap the funds without having to call a Special Church meeting to receive authorization.

Moderator asked for questions – Dorothy Blanchard asked if this is only to come from interest of this fund? Bob indicated that it is coming from interest and capital gain. Dorothy asked if it is possible to have a restriction on this for one year – Dorothy indicated that she would rather not like to see something that is carte blanche without a restriction on it. If all were in agreement – Bob said he would withdraw the motion – and make a revised motion. Bob Knapp withdrew the motion – the second was also withdrawn.

A motion was made that the Church vote to allow the Treasurer with the approval of the FINCOM – to expend proceeds from the Housing Endowment – first to offset the Housing Allowance and then to offset any deficit for 2008. Seconded – discussion requested – the vote taken and the motion carries unanimously.

Article III -

George DesRochers moved that the Church vote to accept the 2007 Financial Report and 2008 Budget as printed. The motion was seconded – discussion called for. Bob Knapp. said that the top of page 16 should read for year 2007-2008 not 2006-2007.. Bob had some general comments: Receipts from the collection plate have remained at about \$110,000 for the last three years and we are projecting the same for this year. Our disbursements continue to rise each year, while our total income has declined. Taking in less and spending more doesn't work well. Our investments showed modest gains through October but then nosedived during November and December. Since there were no raises in 2007, we voted a cost of living increase of 3% for our long serving employees (Ministers, Music Director, Organist, Collector and Treasurer). Utilities – fuel prices have increased \$2,000 for 2007. Please be mindful of making sure lights iare out, doors are closed etc.

The FinCom also decreased the percentage of our pledges that we send to UCC for mission work from 6.8 to 5%. We hope this is temporary. We will take all Church Fair profits and apply it to the general fund. In the past half of the fair proceeds were used for the General Fund and half were added to our Reserve Fund. There are no savings plans of any type for 2008. Our building is aging and has not had attention for some time. These are not things that the FinCom enjoy reporting, \$44,000 lost in 2007 on top of the \$26,000 we lost in 2006. We are hopeful that initiating the Hospitality and Stewardship Committees will help to assist our church to grow,

Any additional questions or comments – the vote taken – the motion carried unanimously. Anyone wishing to have a detailed financial report – please see Bob Knapp.

Article IV

Joan Chatterton moved that the church vote to elect the slate of Officer, Boards, Committees, Coordinators, and Auditors listed in the Nominating Committee's Report for the January 27, 2008 Annual Meeting and that to signify such election, the Clerk be directed to cast one ballot in favor of the slate as presented. Michelle Brock presented the slate of Officers, Boards, Committees, Coordinators and Auditors to be elected for 2008. The motion was seconded. The moderator asked for discussion – any questions – Are the TBA's going to be filled. The Nominating Committee is working on this and have not yet found people to fill the open slots. The vote taken – the motion carries.

The Church By-laws require that the Clerk of the Church be sworn in to office. Allan Barlow, Moderator Pro-Temp swore in Emily J. Knapp as Clerk of the Church.

Article V – To hear and act on any other business and to take any other actions, relative to the Church and its property, which may be brought before the Annual Meeting I accordance with the Bylaws, or take any other action in relation thereto;

Dorothy Blanchard indicated that she has thought over many things and has spoken to many people prior to this meeting in regards to the budget, Church school etc. She is extremely concerned with what is happening in this Church; including Karen Flom's letter accusing us of not being open to change. Dorothy has not seen a resistance to change by the members in this Church over the years. That we have been open to try new things. Dorothy said that when she came up the elevator and saw that there were only two classrooms to take care of children from grades 1-9 she was greatly shocked. This is so wrong from an educational stand-point. Dorothy indicated that she has much experience in education (secular and religious). When we discussed having a Co-Pastorate it was to aid in strengthening the Church school and Youth programs. In 2003 this Church had 130 Church School children. Why is Church School so small - because we don't have teachers - then there is something wrong. Dorothy said that she feels it is a reflection of the Church - some people have walked away from the church - it appears to be a crisis – we are an independent Church – no one will pull us out of this unless we take care of this ourselves. At Special Church Meeting in 2006 when it was voted to have the Co-pastorate, it was voted there would be an evaluation criteria set up by the Diaconate, with the help of Area Minister. We all need to pull together - reach out to those who aren't here at the meeting. We are the only ones to help get us out of this situation.

Dorothy moved that the Diaconate, with the help of the Church Cabinet and with input from the pastors, establish an evaluation criteria for the Co-Pastors positions. This would include some measurable objectives. These criteria would be used for the Annual Evaluation of the Co-Pastors. The criteria to be completed by April 30, 2008. The motion was seconded. Allan asked for comments, questions, discussion

- is April 30th an achievable goal? It seems that the expectations of the Co-pastors and the expectations of congregation is different – if we can come with some agreement on this, the better off we will be. Beth Desrochers asked if it was felt that we need the help of the UCC I this matter? Do we need the help of an impartial person to help us to accomplish this? By giving the discretion of the Diaconate and the help of the Cabinet they can decide who can help.. Is this going to get lost with an April 30th date?

Joan Chatterton indicated that she is very concerned with this matter. The Nominating Committee has worked to try to fill open positions. We do not have a full house in the Diaconate. This is going to put tremendous burden on the Diaconate. Brand new people going onto the Diaconate who need to get their feet wet. It was suggested that the evaluation criteria be completed by the June 30th. Moderator asked if this was an amendment to the motion – Joan indicated that it was. The motion amended to change date to 6/30/08 – motion seconded. Kristen Arsenault, a Diaconate member indicated that it was her opinion that the evaluation process is a very serious process – without a full committee it will be difficult to complete this criteria by April 30th. This is new territory for all of us – the Diaconate will want to look at all the options and be able to do the best for the Church and to the Co-Pastors. Logical to give the Diaconate until 6-30-08. Jeff Fitzpatrick, also a Diaconate member indicated that the April date would be a real challenge – the Diaconate does need to get at this – Diaconate complete this in May and bring to the Cabinet in June 2008.

Ready for a vote on the amendment or a June 30th date??? Joan changed her amendment to "report back at the June Cabinet meeting." The motion was seconded. Criteria to be completed by the June Cabinet meeting – voting on the amendment only Amendment carries –

Vote was taken - the motion carries.

Any other business to be brought up under Article V.

Seeing no additional business at hand, Tom Stewart was asked to come forward and officially close the meeting;.

Motion was made to adjourn and enjoy the Pot-luck luncheon at 12:33 PM.

Interim Pastor's 106-Day Report!!!

(Sept. 15 - Dec. 31,2008)

Dear friends in Christ!

Grace and peace to you in the name of Christ Jesus! Being an Interim Pastor often gives me glimpses of what it must have been like for Paul to travel among the New Testament churches of the Mediterranean in the sense of having the privilege of witnessing how the Word and grace of God have called forth the faith of the people in particular times and places. It is especially good for me to be spending this time with you. I am grateful for the call as your Interim Pastor and I am especially joyful at walking with each of you in this very unusual and historical time that we are living. We have been given a unique opportunity to contemplate God's will for our lives in this time and place.

It is also good for me to be here in the Northeast where I can spend time with my Mother, brother, and sister as well as old friends and colleagues. I am enjoying being a bicoastal family and have appreciated your encouragement and support as I travel back and forth to Seattle for the marriage of our daughter, Kate. I arrived here in September soon after the marriage of our son, Hans. Some days I just marvel at the fullness of life these last few months having BOTH my children now married, having negotiated a move across the country to my beloved northern New England, settling in as a 'townie' in my downtown 'hermitage', and thriving as your Interim Pastor because you have been so responsive to the work of this interim time. Most days I still find myself chuckling about the Australian aboriginal practice called 'walk-about' where one stops and rests along life's journey so 'the soul may catch up with the body.' I feel as if I am becoming a master of this 'walk-about' path.

'Walk-about' is also an appropriate term for interim ministry. The congregation gets to stop for as many months as needed to wait together as you discern what God is calling you to be and become. Another way to talk about the interim time is as an 'in-between' time; that is, 'inbetween' settled pastors. This precious time allows the congregation to catch its breath and reflect on where you have been as well as discover where you are called to move on together. One of the mistakes that congregations make if they don't take the interim time seriously is to enter the pastoral search process asking the question 'what kind of minister do we want' rather than 'what kind of congregation is God calling us to be.' To take the time to contemplate God's desire and call to this congregation FIRST will allow the next pastoral search committee to find a settled pastor with the right gifts to support you in your call as a congregation. This is what we mean when we talk about finding a 'good match' between pastor and congregation.

At my request the Church Cabinet, in collaboration with the Board of Deacons, has set up an Interim Team (please see their report enclosed) to work with me during this interim time. The initial design of this interim period was that the first three months would be spent 'getting acquainted' with the congregation including beginning getting to know the congregation and the Massachusetts conference. After the first three months, we would set up a series of congregational reunions for the congregation to assess more deeply its identity, its gifts and resources, and its dreams for ministry – which when combined will help us all articulate the 'kind of congregation God is calling you to be'. We begin those reunions January 18 and will continue through early April – weather permitting! After these reunions are complete the Cabinet will begin talking about setting up the Pastoral Search Committee. My first three months with you have been mostly delightful, curious, heart-warming, challenging, intense, full of humor, good will, and food! (As one of you keep reminding me 'we love to laugh, sing, and eat! ' That seems to be true!) We are beginning to get to know one another and the healing has begun. I believe it was mid-October that I realized that some sort of cloud had lifted in the congregation – and I could actually sense the deep faith of the congregation. The cloud of fear had begun to lift. I knew you were on your way to discovering yet again who you were, whose you were, and what God wanted you to be about. It has been very, very good to drop into the midst of such a dedicated staff in Bob and Emily, Rachel, and Michelle. Our competent staff increased by one with the hiring of our new CE Director, Gloria Webster. We've all begun the process of team building as a staff by meeting at least twice a month since October.

In December I gave the Church Cabinet an abbreviated 90-day Interim report. After visiting and meeting with lay leaders and members as well as friends these first three months I wanted to make an observation and a request. The observation was that it seemed that there was much misinformation and misunderstanding even within the Church Cabinet as to just what had happened leading up to and including the Marean's resignation and departure. In addition to leaders and members having left the congregation hurt and frustrated, many congregants were still unclear and uncomfortable at not having an outlet for sharing their experience. These realities have also led to misunderstanding between members and lay leaders. I have spent a great deal of time listening and facilitating staff, lay leaders, and small groups of members and friends as they have come to grips with their experiences and perceptions. My request to the Cabinet was to set aside an evening separate from the regular meeting time to invite those who shared leadership these last two years to come together to process their own individual experiences as well as ask one another questions so as to have some more closure around these last two years. The Cabinet agreed and set Monday, January 12 as an evening to begin this intentional story-telling. The hope by all is that more mutual understanding will emerge and healing will continue so that the leaders/staff/congregation may move on. After this meeting these leaders will decide what next steps need to take place in order for the wider congregation to also have opportunities to process their experiences in addition to the congregational reunions.

You are a friendly, strong and resilient congregation with a deep faith in God and a deep longing to be a vital Christian community. That so much good humor exists in the midst of your disappointment and grief is all good. The Church Fair, the many community groups using your facility, the expanding Church School, the desire for more adult education and Christian spirituality, the visits you make on one another, the hours you give to 'inreach' and caring for one another, the wonderful 'outreach' and missions opportunities, the music programs , the commitment to children and youth, your patience with me – all these speak volumes of the life in Christ that you already share. I look forward to continuing my quest to visit with every member/friend during my time with you. I look forward to the congregational reunions and discovering with you how you will see and articulate your sense of God's call.

Thank you for sharing this 'walk-about' with me. "God is good. All of the time!"

MODERATOR'S REPORT

I would like to take this opportunity to review the Moderator's participation in the business of the church over the past year and discuss goals for the future. Before discuss goals for the last year, I would like to thank the members of the First Congregational Church of Georgetown for the opportunity to serve as your Moderator. I respect this office and the church and promised at the onset of my service to make decisions which I believe are in the best interest of this church while putting any personal relationships aside. While there were many challenges over the last year, there were also many wonderful moments. I believe that 2008 will be viewed in the history of this church as a year of transition. It is an honor to be entrusted to serve as the Moderator during such a transitional time in our church as these periods are often met with distinctive challenges.

After being elected during the 2008 annual meeting, my first official duty as the Moderator was to close the meeting. Immediately following that meeting, the Co-Pastorate, Sara and Eric Marean, informed me in private they would be giving their notice at some point in the near future and leaving the First Congregational Church. This was surprising and it also placed me in the midst of a challenging situation. As a first term Moderator I had to learn and understand what the issues of the church were and quickly decide how to best deal with these matters in a manner that was in the best interest of the church. Some of the first meetings I scheduled were with United Church of Christ (UCC) Associate Conference Minister, Rev. Carol Atwood-Lyon, previous Acting Moderator and then Chair of the Trustees, Alan Barlow, Finance Chair/Music Director Bob Knapp, Diaconate Chair Jeff Fitzpatrick, and, Co-Pastorate Eric and Sara Marean. I also had conversations with previous Moderator Karen Flom and other members of the church community. Some of these members had actually left our church. Additionally, I joined the Alban Institute weekly newsletter distribution and began reading as well as researched information regarding churches. One topic I explored was the process leading up to the creation of a Search Committee for a Settled Pastor. I learned that while interviewing for a position of Settled Pastor, most clergy members closely examine how a church said goodbye to the previous Settled Pastor. Candidates for a Settled Pastor position will both ask Search Committee members directly and indirectly as well as consult with other clergy members on the process of a church community saying goodbye to the previous Settled Pastor. This process of saying goodbye is considered by some in church circles to be one of the first steps in the search process for a future Settled Pastor.

On Sunday May 18, 2008, The First Congregational Church of Georgetown said goodbye to the Co-Pastorate Sara and Eric Marean. The process of saying goodbye to clergy is challenging under any circumstance. And, saying goodbye to Sara and Eric Marean was no different. It was in the best interest for each of us, the Co-Pastorate and the future of our church to create an ending experience that was positive, respectful and Christian in nature. For each of us and the Co-Pastorate it was important to establish as much closure as possible while saying goodbye. And, for the future of our church, it was critical to say

goodbye in a way in which we could look back upon and be proud. As previously mentioned, it was important to be mindful of the fact that any future candidate for Settled Pastor will closely examine how our church said goodbye to our last Settled Pastor. This process was the first corner stone laid in beginning a search for a settled pastor. The First Congregational church of Georgetown met this challenge by saying goodbye the best way possible. During the 90 day period following the resignation of the Co-pastorate, it was the responsibility of the Moderator to assist the Co-pastorate and the church in developing an ending experience that was positive. At the conclusion of the 90 day period, both Eric and Sara Marean individually thanked me for assisting in making the period of closure a positive experience for them.

While the church was working on the process of saying goodbye, the Diaconate was working with Rev. Carol Atwood-Lyon developing a profile of our church to begin the search for an Interim Minister. During a meeting on March 5, 2008 with the Reverend Carol Atwood-Lyon, the Diaconate identified some issues. The possibility of having a consultant work with our church was discussed and the Diaconate agreed this would be worth exploring. After the meeting via email, the Rev. Atwood-Lyon provided three names of consultants and I contacted two. Leading up to a July 8, 2008 joint meeting, the Rev. Ellie Richardson of Transpective met with the Diaconate and Cabinet with the intent of "having a conversation". On July 8, 2008, Rev. Ellie Richardson presented a one year and two year proposal for her services as a church consultant. The meeting concluded that the church would decline the Transpective proposal at this point in time but it may be reconsidered in the future after the Pastoral situation was settled.

In total, the Diaconate and I interviewed eight candidates. The role of the Moderator evolved into discussing challenging developmental issues of church over the last several years. In late June 2008, we were ready to make an offer to one candidate for the position of Interim Minister. This candidate essentially withdrew as she decided to relocate out of the area before the offer had a chance to develop. This left some feeling discouraged as a whole 'pool' of candidates we had interviewed found other positions. I suggested in an email to the Diaconate that "good things come to those who wait". The Diaconate and I began interviewing again in July. As many know, my family spends much of the summer in Prince Edward Island, Canada. Prior to leaving for Canada, we interviewed one candidate. Additionally, Chairman Jeff Fitzpatrick and I drafted a letter which was sent out to the congregation after I left for Canada in July. During my time in Canada, church business continued to be managed. I remained in touch with Chairman Jeff Fitzpatrick and the church office via dial up email and telephone. And, the Moderator participated by interviewing two candidates via telephone. One of course, was the Reverend Deborah Adams who we hired in September 2008.

In summary, there were many challenging events during year of 2008 for our church. And for a newly elected Moderator, the learning curve was rapidly accelerated. I have enjoyed all of the challenges and opportunities to contribute to our church while serving in my role as Moderator. I thank all of the members of the church for their support and challenges over the last year. On a personal note, I especially want to thank my wife Jo, our children Skye and Cameron for their support and patience as the time commitment to our church as I serve as the Moderator has meant that I have been, at times, less available in my role as a husband and Dad. I also want to thank my mother, Charlotte, for all of the babysitting both here in Georgetown and in Canada as I attended to church business. I also want to thank Chairman Jeff Fitzpatrick and the Diaconate for their support and efforts in answering the call to hire an Intentional Interim Minister. The following are some goals I believe are in the best interest of our church for 2009:

1. It is my goal that we all work together in supporting our first ever paid Christian Education Director with the intent of helping our Christian Education program grow. It is my hope and prayer that more families will attend our church resulting in an increase of the number of participants in our Christian Education program.

2. Continue to embrace the leadership of our Interim Minister and support her strong presence at the pulpit. Rev. Deborah Adams was the best candidate for the position and we are very fortunate to have her as our Intentional Interim Minister. I pray that our relationship as a church will continue to grow and develop while she serves as our Intentional Interim Minister.

3. I look forward to hearing from and embracing the recommendations from the newly created Personnel Ad hoc Personnel Committee that began meeting in January 2009 following a vote from the Cabinet in late in 2008. This committee will be taking a look at whether or not our church should form a Personnel Committee. In March 2008, I contacted the UCC National office in Cleveland, Ohio to discuss personnel practices in UCC churches nationally. After many conversations and much dialogue within our church, the Cabinet voted to form this Ad hoc Personnel Committee.

4. As a church, I believe we all need to develop and implement a plan to resolve our financial issues. We need to discover new ways of increasing our revenue intake. I believe that all members of the church, including the children, should participate in this dialogue.

5. There has been discussion in the Diaconate and other areas in the church regarding the creation of a Covenant/Decorum of behavior for elected/appointed church officials. I feel strongly we need to have further dialogue about this issue. As a church, we should have the highest expectation of our own behavior while conducting church business.

6. 'Rev Deb' has introduced the concept of "Dialogue versus Debate". Developing our capacity to dialogue as a church is in the best interest for the future of our church. Over the last year in my role as Moderator, there have been times in which I have shifted into full debate mode. During some of these moments, I acknowledge feelings of some have been hurt. I feel it is appropriate to look towards the Lord's Prayer "forgive me for my sins (trespasses in some churches) as I forgive those who sin against me". In 2009, the Moderator hopes to "mend some fences" and heal relationships which may have gone awry.

7. I believe we need to work towards changing our bylaws and functioning much like the Diaconate currently operates. Some key positions in the church should have an assistant with the intent of that individual serving as an understudy who will in serve in the lead position in the future. I believe that such a path of leadership development is helpful to our church for many reasons. First, an organization which has leadership opportunities helps both the individual and organization grow. Second, after any individual serves in a

leadership role, that individual is more likely to have a higher degree of investment in the organization. I look forward to much spirited dialogue over this issue in the future.8. The church will be ready to form a Search Committee for a Settled Pastor after we complete 'Rev' Deb's' workshop series.

9. We are blessed with a wealth of historic documents in our building. Some, I believe, are over two hundred years old. We need to protect these documents by storing them in our building with a fireproof and flood proof method.

10. A former member of our church told me they believe the church is "struggling to find its' identity". With that, some others have suggested there is a struggle between traditional and liberal members of the church. I raise these questions for dialogue, why can't we be both? Why can't we work towards a model of having two Sunday services with one being more traditional and the other being more progressive? This, I believe, will help our church grow and meet the challenges that all churches face in this day and age.

Chairperson's Annual Report 2008

The Board of Christian Education started '08 with the surprise news that our pastors would be leaving in May. This was of particular concern to the committee since this meant that we would be losing our Director of Christian Education.

In February the Sunday School held the annual Valentines cookie and candy sale to raise money for the Heifer Project. We raised \$321 at this event. In the Spring the SS classes would vote for an animal to buy with the funds raised.

In March, Eric decided to reorder the Seasons of the Spirit curriculum since teachers seemed to feel positive about using this curriculum.

The members of the Board of Trustees, Chairman Rich Brock, Chris Pinto, Steve Pinto, Jeff Gillen, Alan Barlow, and Jo Stewart have had a productive year.

Chris Pinto served as a Trustee until September 2008. He vacated his position as a result of attending college. Steve Pinto filled this vacancy. We also need to extend a special thank you to Chuck Davis and Steve LeBlanc for their ongoing assistance with the electrical, heating, computer, and sound systems.

The lawnmower broke down at the beginning of the season and it was beyond repair. The decision was made to delay the purchase of a new one in the hopes of either purchasing an inexpensive used one of receiving a donated one. While these options materialized, the trustees used their personal mowers. Finally, at the end of the season, a lawn mower was donated to the church. Special thanks to the Trustees that donated their lawnmowers, as well as to Benjamin Brock, Jonathan Brock, Chris Pinto, and Alex Pinto for their willingness to assist.

Mulch was donated to the church and spread amongst the bushes and flower beds. The Trustees assisted with the set up and dismantling of tables and shelves before and after the Church Fair. The boiler was cleaned and serviced, with no notice of needed work. However, during the summer, a valve became faulty, causing the boiler to overflow. This was repaired, with no additional issues.

The fire alarm box has an internal alarm that has gone off on occasion. The sensors throughout the church were checked and corrected, which has solved the issue. The emergency lights and fire extinguishers were inspected. Per instructions from the Fire Department, the emergency lights in the kitchen were repositioned.

Shoveling was done as needed, with sand and salt laid in for general use. The snow blower is still running and has had a busy 2008/2009 winter.

The structural damage on the front of the church was not repaired as anticipated. The work will be done in the spring of 2009. The estimate of \$12,000 includes the necessary repair, as well as painting the front trim. The structure is temporarily secured, with assurances from the contractor that it will hold up until the repairs are done.

The fee schedule for the general use of the church was revised this year, which includes a fee for the Sexton, who is responsible for keeping the church clean. New contracts for the church use will incorporate these new rates. Changes to existing contracts are also occurring. Changes are necessary to help defer the daily costs of running the church.

The property and workman's compensation insurances were re-evaluated to determine whether savings can be realized if we change Insurance Company. The final evaluation and recommendation will be made during the 1st quarter of 2009.

The Sexton has done an excellent job this year. We are grateful for her efforts in keeping the church clean and tidy for all that use the church.

The storage room for CE has been converted to a Youth Group Room. The new CE storage room is now located on the second floor. In terms of the Youth Group Room, all materials have been donated, including the furniture and the television. Some repair work is needed along the doorway, which will be done in the spring.

We thank members of the Board of Trustees for painting the room and wallpapering a border. Members of our group, Isabel Gammon and Vivian Rasmussen, gave much time and attention to this renovation. Future plans are to refurbish the shelving, add glass doors, and display archival objects.

In May we said goodbye to the Marean family, Sara, Eric and little Zeph, as they moved on in their ministry. We expressed appreciation for the attention they gave to us as a group, and wished them well in a new calling.

"Creating Miles of Smiles" was the subject of the September meeting, presented by photographer, Lisa Bartlett. Lisa told of her trip, with the Rotary International, to Columbia where she served as official photographer to record the good works of doctors and nurses who treated children with cleft palate deformities due to vitamin deficiencies. Report Of The Missions Coordinator For 2008

Thanks to all for your contributions to the mission efforts and activities of our Church. Your time, talents, efforts and resources are much needed and greatly appreciated. Many opportunities exist on a daily basis for each one of us to make a positive difference in our local communities and beyond. The following are some of our mission activities for the year while additional activities are reported by other groups, committees and/or boards:

- The Church School Valentines' Candy and Craft Sale raised funds for Heifer International.
- The Lenten Offering was divided with 80%, or \$855.20, being directed to the Reserve Fund and 20%, or \$213.80, to the Diaconate Fund.
- In April a donation was made to Habitat for Humanity to aid Lawrence fire victims. We donated \$225, of which \$100 was contributed by the Diaconate.
- Offering collected for One Great Hour of Sharing in May was \$262.00.
- During the summer the Diaconate approved \$100 to help fund a two-week missionary trip to China for a local family.
- Newsletter information for various events: Earth Day in April; Hike for Habitat for Humanity in NH and Milford, MA, in June; and Emmaus, Inc.'s "Cycle for Shelter" in July.
- Non-perishable food items, gift certificates and checks were collected Children's Sunday and Thanksgiving Sunday for Emmaus House in Haverhill. Food was critically low.
- In October we participated in and raised funds for the Jeanne Geiger Crisis Center 17th Annual "Walk Against Violence" (\$380.00) and the First Annual Crop Walk (\$100) to raise awareness of and support efforts to end hunger and proverty locally and internationally.
- In November I attended a meeting at Maple St. Church sponsored by the Essex Association and the Mass Conference Team to End Homelessness.
- The Advent offering was divided with 50% being allocated for food gift certificates for local families in need and 50% directed to the Reserve Fund.
- Christmas gifts were donated to H.O.M.E. (Homeworkers Organized for More Employment) in Orland, ME, for children who would otherwise not receive gifts.
- Contributions to the Massachusetts Conference UCC for funding of outreach programs were 5% of our weekly pledges for a total amount of \$4,056.13 for the year.
- Offering collected for Neighbors in Need was \$309.00.
- Church contributions were made to the scholarship fund at Andover Newton Theological Seminary, \$300.00, and the Essex Association fund for in-care students, \$400.00.
- · Donations were made to stock the Church Pantry for those in the community needing a helping hand.

Please let me know of any suggestions, ideas or thoughts you may have for future mission activities/projects we might pursue. Finance

Report of the Finance Committee

A great big thank-you to all who contribute to this church. Your continued support keeps this church and it's ministries a vital part of Georgetown and beyond. The Finance committee would also like to thank JoEllen Fielding & Peggy Smith for the amount of time and effort they devote to their respective positions as Collector and Treasurer. These are tough, detail oriented jobs which they continue to cheerfully perform. Finally, a special thank-you to Dave Smith, not only for assisting Peggy, but also for producing our Lenten & Advent envelopes.

We were happy to begin 2008 by welcoming Tim Clift as our newest member. His investment expertise is a much appreciated addition. 2008 turned out to be a very tough year, financially. Like many of you, the church was hit hard by our economic down-turn. Our investments declined in value more than 28% or approximately \$105,000. Additionally we needed to withdraw a little over \$21,000 to make up the difference between what we took in to run the church and the actual costs.

The church finished the year with a current expense deficit of nearly \$40,000, despite the fact that we saved some \$25,000 by not paying for ministerial leadership for 4 months. Our income was down almost \$17,000 when compared to 2007.

The Finance Committee is also concerned that our Quantity of pledgers and regular givers has declined by half since 2003. Expenses, as you may have suspected, continue to rise every year. Our aging facility, long overdue for renovation, again received only absolutely necessary attention. Our proposed budget, cut to the bone, is some \$75,000 out of balance. The only way to cut further is to make some drastic changes, which will be very difficult to restore once they are made. With input from the cabinet, we decided to "limp" along for another year on the backs of our endowments as we look for divine inspiration.

We are optimistic that, with our fresh start with Rev. Adams, we will grow our church family and find additional opportunities to raise capital. We trust, with God's help, that we will meet this challenge.

The following pages contain a basic breakdown of our church's income and expenses for the year as well as the proposed 2009 budget. Each category has 4 columns of figures.

The first column (2007 Actual) shows what we received & spent in 2007 The second column (2008 Budget) shows what we planned for 2008 The third column (2008 Actual) shows what we actually took in & paid out in 2008 The fourth column (2009 Budget) shows our plan for 2009

At the top of page 1 is a recap of our financial assets at the start of the year. Following that is a listing of annual receipts. Finally there is a review of our investment's performance. We acquire capital from our investments two ways. First, in dividends and interest, which are paid to us on a regular basis; Second is Capital Gains. The various items (stocks, mutual funds etc.) that we posses increase (hopefully) in value. We only receive this if we "cash in"our investments.

The second page lists all of the ways we spent our money.

Beginning page 3 is a recap of our financial assets at the end of the year. The second section demonstrates the annual results.
95 % of pledges and 100% of all other non designated income are used to keep the church running.
5% of pledges, a portion of special collections, and 100% of any direct appeals or fund raising is donated to those in need. (Missions) A portion of special collections and our investment's income is set aside for our future.
When expenses exceed income, (We wish that was "If" instead of "When") we must dip into our savings to meet the short-fall. The last section on this page explains where we do the dipping.

Page 4 presents the various Funds & Endowments that make up the church's assets.

Endowments are special donations to the Church, with the stipulation that the original amount be invested but never spent. The Church may use the proceeds. We reinvest 10% of the dividends & interest back into the endowment to help it grow. Capital gains are left in the endowment but are available should the need arise.
