WARRANT

The Members of the First Congregational Church of Georgetown are hereby advised that in accordance with the Constitution and By-Laws of said Church, the Spring Meeting will be held on the second Thursday of May, May 14, 1959, in the Church Vestry at 7:30 P.M. then and there to act on the following listed articles.

Article 1. To hear any reports to be submitted by the Officers and committees of the Church and to take whatever action is desired on or resulting from them.

- Article 2. Annual Budget, to see whatever action is desired on the adoption of a budget for the Church Year.
- Article 3. Nomination and election of Officers and Committees.
- Article 4. To hear and take any desired action on several proposed amendments and changes to the Constitution and By-Laws as presented herewith;
 - 1. Change Article IV, Section 4(f) to read: "It shall have regard for the discipline as provided by these By-Laws; shall be watchful for the spiritual interests of the Church and shall fill any vacancy that may arise during the year, save that of Descon."
 - 2. Article IV, Section 1(g) to read: A Board of Deaconesses to consist of five Deaconesses to be chosen from the Covenant Membership. At the Spring Meeting at which this paragraph is adopted, one is to be elected for a term of five years, one for a term of four years, one for a term of three years, one for a term of two years, one for a term of one year; thereafter, and to be elected for a term of five years. No Deaconess shall be eligible to resume office as a Deaconess until one year after her prior term shall have elapsed. The Chairman of this Board shall be that member serving the last year of her term of office.
 - 3. To change Article IV Section 1(g) to Article IV, Section 1(h). Voted
 - 4. Article IV, Section 3(g) to read: "Board of Deaconesses.
 There shall be a board of five Deaconesses, one of whom shall be elected at each annual meeting for a term of five years, and after having served one full term no Deaconess shall be eligible for reelection until after the lapse of one year. The Deaconesses shall visit the sick and needy, call upon new members, introduce new femilies into the life of the Church and cooperate with the Pastor in promoting the Spiritual interests of the Church.
 - 5. Article IV, Section 2(c) to be amended to reads Board of Christian Education, to be composed of seven members, which shall include the Minister and the Superintendent of the Church School, the five general members to be elected at the Spring Meeting following the adoption of this paragraph, one to be elected for a term of five years, one to be elected for a term of four years, one to be elected for a term of three years, one for a term of two years, and one for a term of one year, and thereafter each to be elected for a term of five years. The Chairman of this Board shall be that member serving the last year of his term of office.
- Article.5. To see what action the Church will take in regard to appointing or causing to be appointed a Survey Committee of at least five members, whose duty it will be to make a survey of the needs of our Church and a preliminary report to be made at the next regular meeting of the Church.
- Article 6. To take any other action desired, relative to the program of the Church and/or its property.

WARRANT

The Members of the First Congregational Church of Georgetown are hereby advised that in accordance with the Constitution and By-Laws of said Church, the Annual Meeting will be held on the second Thursday of October, October 9,1958, in the Church Vestry at 7:45 P.M. then and there to act on the following listed articles.

- Article 1. To hear the various reports to be submitted by the Officers and Committees of the Church and to take whatever action is desired on or resulting from them.
- Article 2. Annual Budget, to see whatever action is desired on the adoption of a budget for the Church Year and the raising of money to meet same.
- Article 3. Nomination and election of Officers and Committees.
- Article 4. To hear and take any desired action on several proposed amendments and changes to the Constitution and By-Laws as presented herewith;
 - 1. to delete present Section 2 (e) of Article V. of the Constitution and substitute the following "There shall be two Regular Meetings of the Church held each year, one, the Spring Meeting, to be held on the second Thursday of May, at which time the proposed budget will be presented and acted upon, and the officers and committee members to take offic on September first will be nominated and elected by ballot. The other Regular Meeting, the Autumn Meeting, to be held on the second Thursday of October, at which time the several officers, boards, committees, and organizations of the Church will present their reports of the preceding year. The fiscal and report year shall be from September 1 of one year to August 31 of the following calendar year
 - 2. to delete that portion of the Constitution and By-Laws beginning with Article IV., Section 1,(e) through Article IV., Section 2,(h) and substitute the following-

Article IV, Officers and Committees.

Section 1.

- (e) A Board of Deacons, to consist of five Deacons to be chosen from the Covenant Membership, one to be elected at each Spring Meeting to serve for a term of five years. No Deacon shall be eligible to resume office as a Deacon until one year after his prior term shall have elapsed. The Chairman of this Board shall be that member serving the last year of his term of office.
- (f) A Collector, to serve for one year and until his successor shall be chosen.
- (g) All officers of the Church, except the Minister, shall be chosen from the Covenant Membership of the Church and be elected by ballot at each Spring Meeting, except as may be provided flsc where in these By-Laws.

Section 2. The Committees of this Church shall 1

(a) Finance Committee, to be composed of three members, one member to be elected at each Spring Meeting of the Church, 1 serve for a term of three years.

- (b) Church Delegates, two to be elected at each Spring Meeting of the Church to serve for a term of one year.
- (c) Board of Christian Education, to be composed of five members, which shall include the Minister, and Superintender of the Church School,

- 3. The following listed changes under Article IV, Section 3. Duties of Officers.
 - under (a) Minister delete the word annual and add the word Autumn so that the last sentence shall r "He shall present a written report of his wor at each Autumn Meeting of the Church."
 - under (b) Clerk revise fifth sentence so that it shall read "At each Regular Meeting of the Church he shall present a written report of the stat of the Church Membership including the above mentioned items together with any other items of interest to the Church."
 - under (c) 4. revise the last sentence of paragraph one so that it shall read- "He shall exhibit his books and records to the Cabinet at any time and shall make a written report of the Church Finances, certified by the Church Auditing Comittee, at each Autumn Meeting of the Church.
 - under (d) Church School Supermntendent revise the las sentence so that it shall read - "He shall present at each Autumn Meeting of the Church a written report of the work of the Church School."
 - under (e) Deacons

 9. revise the wording so that it shall read9. They shall periodically evaluate the work of the Minister as regards the spiritual and social life of the Church, and report their finding to each Autumn Meeting of the Church during a period in which the Minister is requested to absent himself."
 - under (f) Collector revise the last sentence so that it shall read " He shall exhibit his books and records to the Cabinet at any time; and shall make a written report of his collection certified by the Church Auditing Committee, at each Autumn Meeting of the Church."
- 4. The following listed changes and revisions under Article IV., Section 4. Duties of Committees.
 - under (a) Finance Committee- revise the wording of the fourth sentence so that it shall read" They shall prepare and lay before the Churc at the Spring Meeting, an itemized schedule of the estimated expenses of the Church for the ensuing year, and also their recommendations as to the method of raising the necessary fur to meet such expense."
 - under (f) Cabinet revise the wording of the fourth
 sentence so that it shall read "At least
 four weeks before the Spring Meeting of the
 Church the Cabinet shall appoint a Nominating
 Committee to present recommendations for the
 election of all Officers and Committees at
 the Spring Meeting."
 - under (g) Auditing Committee revise the wording so that it shall read "Auditing Committee, she audit the books of the Treasurer and the Collector prior to each Autumn Meeting of the Church and present a report on each to the Church."

- 5. Article V. Meetings, Section 2 (c) revise the wording so that it shall read -
- (c) "The Regular Meetings and Special Meetings, to act upon matters pertaining to finances, property, or the electior of officers (except as otherwise provided for), shall be called by the Cabinet issuing a warrant to the Clerk directing him to post an attested copy in or on the Meeting House at least seven days prior to the time of said meeting."
 - 6. Atticle VI. Organization revise the wording so that it shall read -
 - "The Church regards as integral parts of itself all organizations formed for the purposes of its ministratic and which use the facilities of the Church property. Ove all such organizations the Minister shall have general oversight, and no new organization shall be formed without the approval of the Church Cabinet. The Church will expea short written report from each organization at the Autumn Meeting each year.
 - 7. Article VII. Amendments, revise the wording so that it shall read -

"These By-Laws and Constitution may be amended at the Regular Meetings of the Church, or at any Special Meeting of the Church, by a two-thirds vote of the members voting, provided that such proposed amendment has been inserted in the Warrant for said meeting."

Article 5. To see what action is desired in changing the appointment of the Superintendent of the Church School.

To delete the present description and substitute the Suggested Amendment to the Constitution and By-Laws Article IV. Officers and Committees

- Section 1 (d) A Superintendent of the Church School, to be appointed yearly by the Board of Christian Education to serve for a term of one year and until his successor shall be appointed.
- Article 6. To take any other action desired, relative to the program of the Church and/or its property.

THE MESSAGE FROM THE MINISTER

We live in a growing town and in a growing Church. There is no doubt that our community is growing for one constantly sees new faces, and new homes are being built on every spare piece of ground, and many of these new people find their way into our Church. Witness the fact that our membership has grown from 272 three or four years ago to 322 in the Clerk's current report. Our Church School has grown considerably in the past years to a current enrollment of well over three hundred. Our High School group numbers over 60 members, phenomenal for a Church and community of our size. Our Church is growing physically, but there is another growth, more important, which needs more examination.

Our rate of physical growth is regretfully not matched by our spiritual growth. Although frequently the case in a rapidly growing church, it is none the less neither necessary nor excusable. The major lack in our Church might well be the lack of a deep sense of fellowship between and among our people and an equally unfortunate lack of sincere dedication to God. Of great significance in the past weeks was the appointment of a Board of Deaconesses whose major work will be to increase the fellowship and concern among our members by visiting the sick and elderly and being on call whenever there is need. But the spiritual growth of the Church cannot be left up to the Minister, or to the Deacons and Deaconesses. However hard they work, or however great their responsibility, ultimately it is up to the people.

Our Church has made great strides financially, physically, and in membership. The one great undeveloped area now is our spiritual growth. Here is where the greatest challenge lies. To meet it and use it as an opportunity for service to God is the rightful task of each of us.

REPORT OF THE CLERK 0/1/58 to 3/31/59

At times during this past year the walls of our Church have fairly bulged with people - from infants to senior members - active in work, in learning, in fellowship, and in prayer. We have had a full and energetic year under the guidance of our Minister, Rev. Mr. Fleming, who will, before long, undoubtedly think of some way to "volunteer" the INFANTry into performing some task. The results of his efforts, however, are evident in the increased membership, interest, and activity in our Church.

The Church Membership Roll now totals 322, with 23 new members having been added in the past year. Three members have been removed by transfer. There have been 26 baptisms and four weddings.

The Board of Deacons held ? regular meetings and 5 special meetings during this past church year starting Sept. 1, 1958 and ending August 31, 1959.

The Board of Deacons consisted of:

It was with regret that the Board of Deacons accepted the resignation of one of its members, Mr. Lewis T. Partington.

On October 19, 1958, the Deacons conducted Layman's Sunday service with an address by Deacon Emeritus, Mr. Robert F. Metcalf - "What Do We Believe". It was an inspiration to the younger Deacons to listen to "Rob" who had completed 40 years as a Deacon on August 31, 1958.

Among the accomplishments of the Board of Deacons for the past year are the following:

- 1. Deacons' table at Church Fair. Money raised from sale of vegetables, eggs, chairs, and religious books and pins was given to the Fair Committee.
- 2. One-year subscription to United Church Herald given to 10 new Church members of previous year.
- 3. Assisted in the acquisition of a portable tape-recorder which is used to record Sunday morning services; is then set up in the home of a shut-in and is played back to enable the shut-in to hear the Church service.
- 4. Purchased additional Communion tray and plates to permit 4 Deacons to serve Communion.
- 5. As administrators of the Poor Fund, the Deacons distributed money at Christmas and other times during the year to those who needed aid.
- 6. Established the Memorial Fund whereby the memory of loved ones who have died may be preserved through fitting memorials in the Church. Whenever a Church member dies, the Deacons place a sum of money in the Fund in memory of that person. The fund also grows through gifts from others who prefer to give money to the Fund rather than send flowers.

Soon a plaque will be mounted with the names of all those whose memory the Fund preserves. Fitting memorials are purchased by the Deacons from the Fund. The first of these is a silver Communion Chalice with the following inscription: "First Congregational Church, In Memoriam, 1959."

- 9. Accompanied the Minister in presenting a petition to the town Selectmen opposing the issuance of a permit to Rocky Run to sell alcoholic beverages on Sundays. At two successive Selectmen's meetings, the Board of Deacons appeared and presented reasons to rescind the permit issued by the Selectmen.
- 10. Recommended the creation of a Board of Deaconesses to consist of 5 members.
- ll. Approved new Deacons for Church-year 1959-1960 to make a total of 5 on Board of Deacons: Mr. Matthew R. Kelloway, Mr. John Bartlett, Mr. Ralph Taber. Present Deacons who continue on the Board are: Mr. William J. Eckel, Chairman and Mr. Harold Elliott, Secretary.

Future plans of the Board of Deacons consist of:

- 1. Acquire a standard baptism font to replace the present font consisting of a Deacon with a basin.
- 2. Set up a display of historical articles of the Church. Through the kindness of a past Deacon, Mr. Partington, a glass-front cabinet is available for the display.
- 3. Provide a policy concerning baptisms.
- 4. Develop more interest in our Sunday morning service and make our Church membership a better worshipping group.

At the September 2, 1959 meeting, the Board decided to have a coffee hour after the 9 a.m. Church Service. On Sept. 6, 13, 20, arrangements to be made and coffee served by the members of the Board. The Board voted to sponsor a Church basketball team which will play in the YMCA Church League. During the month, Mrs. Lewis Pingree and Mr. Fleming went to Andover-Newton Theological Seminary to interview two or three young men for a post of Student Assistant to the Minister.

The course of Study for this coming year will embrace three main areas. In the Fall we will study "Our Church", in the Winter it will be "How the Church Grows" and the Spring Quarter will bring the study of "Christian Living in Our World." We should like to encourage the parents to reinforce our one hour of Christian Education at Church with interest and continued study at home; so this course may be an enriching experience for all.

There were several important "firsts" in the 1958 and 1959 year. First of all was the addition to the staff of an Andover-Newton Seminary Student, Joseph Runner, our student assistant. His particular duties were leading the Junior and Junior High Worship Service, teaching the 8th Grade class, and advisor to the Pioneer Fellowship. His enthusiasm and interest gave us our first strong Junior High program. This work is being continued this year by Robert Bradstreet. It is understood that the Student Assistant's work is primarily "inservice training", but the results show a great contribution has been made in the lives of our young people and thence our church and community. The one need for the Junior High group is more active parental support of the Pioneer Fellowship Hour.

Another "first" was the establishment of 2 High School Classes. There was "no room for them" at the church; so one section met at the Parsonage and another in Dr. Skeirik's Office. There is still "no room"; so this year they will meet at 5:30 Sunday Evening for "The Pilgrim Fellowship Study Hour".

Another "first" was at the opposite extreme of age, for the INFANTry was established. This is primarily a baby-sitting service for parents who wish to attend church and whose children are too young to participate in our Church School classes.

Still another "first" was the change in classes of the Primary and Junior Departments. Starting this Fall the Primary Department consists of Grades 1, 2, and 3, and the Junior Department will consist of Grades 4, 5, and 6.

This report would not be complete without a word of thanks to our very able and interested staff of teachers and Department Superintendents. We have a fine staff who give unstintingly of their time. They come regularly Sunday after Sunday, in addition to their weekly preparation for their classes, their participation in our monthly teachers meetings and the Community Christian Education Institutes.

A word of thanks should also go to the Board of Christian Education. We are greatly indebted to this group who have given a great deal of support to the total picture of Christian Education of our Church and have done quite a bit of work "behind the scenes".

Our minister's work is also much appreciated. He has been actively interested in our Church School Program and has continually helped to support and direct our work.

The latest material addition for which we are very thank ful is the new floor in the "long room" where our first grade meets at 9:30 and our Nursery (3 year olds) meet at 11:00. This has helped to make the room so much more attractive as well as more serviceable for these age groups.

In looking ahead to the new year and still farther into the future we see our greatest need is for more and better class meeting places. The extra space would not only aid Christian Education, but

would also benefit other groups—for instance, the choir, whose entire space we usurp until 10:30, and the morning worshippers who are quite aware of our Pre-School Program which meets during Church time.

We cannot minimize the importance of the Church School Program, for if we give good training, establish good attitudes, and lay a firm foundation of Christian Faith in the lives of our Young People, our Protestant Heritage will continue and the future of the Church Universal is assured. However, this has to be done through the combined efforts of the teachers, the parents, and other members of the church who have the message to share and whose lives serve as examples to our Young People.

The 1958-1959 season was started off with a planning retreat at the Thorn Mountain Betreat Center. It was decided that our group could help the church members in a special way. Members of the Couples Club needed babysitters for the monthly meeting. The group could also help the church by selling grab bags at the Church Fair. Much discussion was held at the retreat. It was brought to the group's attention that teenagers in the South End of Boston were badly in need of sports equipment and recreational facilities. A goal of \$50 was set to help them. Later in the year the group journeyed to the South End to see that the money would be very useful. The retreat was very successful.

Two new programs have been added to the Fellowship. It was decided to have Lenten breakfasts during Lent. A Devotional would accompany them. These were so successful that they were continued.

A Saturday evening program called a "fun-fest" would enable teenagers to have something to do on Saturday evenings. Some of the programs were planned, but most of them weren't. A member could play ping-pong, quiet games, dance or just chat. After attending some of the fun-fests it was agreed by many that selling coca-cola would improve the fun programs and net our group a profit. This encounter proved to be very successful.

Many various programs were enjoyed during the year. Speakers on subjects such as alcoholism, the Jewish religion, diving, Japan, and music appreciation; and discussions on subjects such as dating, segregation, chances of a third World War, and the Pro in Protestantism were very interesting. After hearing about the Jewish religion the group was invited to visit the Jewish Synagogue in Haverhill.

Mr. Coulthard, a former minister in Georgetown, and his New Bedford group were invited to Georgetown for a weekend. They enjoyed programs and church with the Georgetown P.F.

Movies was a popular program. The entire church was entertained on Easter Sunday by a movie sponsored by the P.F. A goal of \$100 was set by the group after seeing a true-to-life movies about the migrants to help these people. Other movies on various subjects were enjoyed too.

Fun programs were on our agenda. Skating parties, swimming parties, dances, a mystery ride, scavenger hunts, and a Bible Treasure Hunt were very successful.

In order to balance the budget money-raising projects were held. All of these were successful. Among them was a car wash, two paper drives and a spaghetti supper.

In May an evaluation retreat was held. The 1958-59 season was evaluated and plans were made to improve the group in the 1959-60 season. The group thoroughly enjoyed holding their retreats at the Thorn Mountain Retreat Center. It was voted to buy a four-dozen set of Melmac

Finance

FINANCE COMMITTEE REPURI

This past church year from Sept. 1, 1958 to August 31, 1959 has been a hectic year - financially, with expenses incurred far beyond those originally contemplated in the Budget; extensive revisions and simplifications made in our accounting procedures of the Treasurer's records concerning regular expenses and savings accounts, and a tremendous Every-Family-Canvass conducted in April under the supervision of Mr. E. Charles Fowlston from our Congregational Christian Conference.

We received and paid out \$5,500 more than we anticipated when we presented the budget at last year's Autumn Meeting. Our total receipts this past church year were \$18,411.20 and our total disbursements were \$18,403.84 as explained in the Treasurer's report, leaving a balance in our Checking Account to start the new year of only \$7.36. Due to a lack of funds, the

the following debts of this year will have to be added to the new year's budget:

If we are critical about budgets, and are looking for the source of our overrun, there were several factors contributing to the overrun:— a colder than normal winter causing greater fuel costs; repairs to the steeple due to wind damage; installation of floodlights and telephone at the Church causing greater electricity and telephone costs; setting up and distributing the monthly Newsletter; and conducting a huge Every-Family-Canvass.

As we review the past year, may we point out that last year was the first full church year under the guidance of our minister, Mr. Fleming, and indications are that our Church is on the move financially. Last year was a record year even though we omitted our regular Autumn canvass and our envelope giving was based on the calendar year (Jan.-Dec.) rather than the church year (Sept.-Aug.)

If the generous response of our people continues, our Church will be able to provide services and facilities that you have talked about and prayed that we had but, perhaps, had small hopes of seeing here. It can be done but not without your help. If I may put in a plug for this new year's Finance Committee and remind you of the slogan of our great Canvass last April -
